Resolution commending James Black as the recipient of the Monterey County Branch	,

WHEREAS, James Black, born in Ashville, North Carolina, became aware of social injustice while growing up in segregated Ashville in the 1940s and 1950s; and

WHEREAS, James Black after graduation from Stephens Lee High School, attended North Carolina Agricultural and Technical State University in Greensboro, North Carolina from 1957 to 1961 on a football scholarship; and

WHEREAS, James Black in 1960 participated in demonstrations at the Greensboro Sit-ins, a series of nonviolent protests. Four college freshmen requested service at the segregated lunch counter of F. W. Woolworth in downtown Greensboro. The Greensboro Four (Ezell Blair, Franklin McCain, Joseph McNeil and the late David Richmond, Jr.) led college students to the "five and dime" store and took a stand for justice by sitting down at the lunch counter, then refusing to leave until they were served. Their bold move initiated a wave of similar sit-ins by college students across the south. The store chain reversed its policy of racial segregation in the southern United States. Other agents for justice among James' peers included teammate Reverend Jesse L. Jackson, Sr., who continues his involvement in the struggle for civil rights; and

WHEREAS, James Black graduated with a Bachelor of Science in Physical Education and was commissioned a Second Lieutenant in the U.S. Army, retiring in 1986 as a Lieutenant Colonel; and

WHEREAS, James Black held military duties which included Alaska; Fort Campbell, Kentucky; and Fort Benning, Georgia, as a student and infantry instructor; and

WHEREAS, James Black served two tours in Vietnam as a Ranger Advisor; and

WHEREAS, James Black in 1973 while assigned in Germany, served as a personal advisor to the Division Commanding General on Race Relations and Equal Opportunity. As a result of troop dissatisfaction, racial tension was at an all-time high. James designed and implemented race relations training programs, investigated complaints, and developed and monitored the Command Race Relations Affirmative Action programs; and

WHEREAS, James Black served as Recreation Service Officer at Fort Ord, California in 1976; and

WHEREAS, James Black has received awards and decorations including the Bronze Star Medal with Oak Leaf Cluster, Meritorious Service Medal, The Army Commendation Medal, Vietnam Service Medal, Armed Forces Honor Medal (Republic of Vietnam), Combat Infantry Badge, Parachutist Badge, and Ranger Tab; and

WHEREAS, James Black in the 1990s became aware of and concerned with the high number of Black men going to prison. He sought a position as a teacher and Recreational/Physical Education Supervisor at Soledad Correctional Training Facility where he worked for 15 years.

While there he implemented athletic and sports programs designed to rehabilitate those who were incarcerated; and

WHEREAS, **James Black** served as treasurer for the Kappa Alpha Lambda Chapter of the Alpha Phi Alpha Fraternity from 2000 to 2014. Since 2010 he has served as treasurer for the Monterey County Branch of the NAACP. In 2012 James received the Pauline Jones Award for Treasurer of the Year at the 25th California-Hawaii State NAACP Convention.

NOW THEREFORE, BE IT RESOLVED that the Monterey County Board of Supervisors does hereby recognize and commend **James Black** as the 2015 recipient of the Monterey County Branch of the National Association for the Advancement of Colored People's President's Award.
