WHEREAS, Commander William Kaye was born in 1964, was raised in Oregon, attended Waldport High School in Waldport, Oregon where he graduated in 1982 and attended Gavilan College, San Jose State College, Sacramento City College and Monterey Peninsula College; and

WHEREAS, Commander William Kaye came to the Monterey County Sheriff's Office after working as a Military Police Officer and K-9 Handler in the United States Army; and
