Adopt a resolution honoring **Bard K. Mansager** as a Monterey County Military and Veterans Affairs Advisory Commission's Veteran of the Year for 2020.

**WHEREAS**, each year the County of Monterey and the Monterey County Veterans Services Advisory Commission honors those who have made a significant contribution to their communities, are strong motivators, have demonstrated extraordinary professional competence and are role models for veterans and the community as a whole; and

**WHEREAS**, the Monterey County Military and Veterans Services Advisory Commission is honored to recognize **Bard K. Mansager** as a 2020 *Veteran of the Year*; and

**WHEREAS**, **Bard K. Mansager** served in the United States Army from June 1, 1971 to June 1, 1991; and

**WHEREAS**, **Bard K. Mansager** in 1993 received the Outstanding Research Achievement award from the Naval Postgraduate School; in 1998 he received the Schieffelin Award; and in 2001 he received the Northrup Grumman Faculty Award for Excellence in System Engineering and Integration; and

**WHEREAS**, **Bard K. Mansager** is a senior lecturer at the Naval Post Graduate School; and

**WHEREAS**, **Bard K. Mansager** has amassed a total of 56 years of volunteer time since 1992 having served ten years on the Board of Directors for Meals on Wheels, four years (and still serving) on the Board of Directors of the Military Officers Association of America (MOAA); six years on the Board of Directors for the Monterey Kiwanis (and still a member); 14 years on the Board of Directors of the Monterey College of Law; six years for Leadership Monterey Peninsula; ten years on the Board of Directors for Monterey College of Law Alumni Association; four years on the Board of Directors for Indian Springs Mutual Utility Company; and two years (and still serving) on the Board of Directors for the Veterans Transition Center.
