

**RENEWAL AND AMENDMENT NO. 1  
TO AGREEMENT  
BETWEEN HARTNELL COLLEGE FOUNDATION AND  
THE COUNTY OF MONTEREY  
ON BEHALF OF NATIVIDAD MEDICAL CENTER**

This Renewal and Amendment No. 1 to Nursing Program Grant Agreement (“Agreement”), A-12268, is entered into by and between the County of Monterey (“County”), doing business as Natividad Medical Center (“NMC”), and Hartnell College Foundation (“Contractor”).

**RECITALS**

WHEREAS, NMC and Contractor entered into Agreement A-12268 dated July 31, 2012 (“Agreement”).

WHEREAS, the parties’ Agreement expired June 30, 2013.

WHEREAS, this Agreement is necessary to meet the continued needs of meeting the direct cost of the Hartnell College Nursing and Allied Health Programs of Hartnell Community College (“Nursing Program”), so as to sustain the Nursing Program and facilitate the availability to NMC and the community of qualified nurses.

WHEREAS the parties to this Agreement wish to extend the term and to increase the maximum liability of the Agreement.

**NOW, THEREFORE**, the parties agree as follows:


1. The Agreement is hereby renewed on its prior terms and conditions as set forth in Attachment 1, incorporated herein by this reference, except as specifically set forth below.
2. The Grant from NMC that is available to Hartnell College Foundation under this Renewal and Amendment No. 1 is increased by Three Hundred Fifty Thousand Dollars (\$350,000) for a total maximum liability of Five Hundred Twenty-Five Thousand Dollars (\$525,000).
3. The term of the Agreement is extended to June 30, 2015.
4. If there is any conflict or inconsistency between the provisions of Agreement or this Renewal and Amendment No. 1, the provisions of this Renewal and Amendment No. 1 shall govern.
5. The effective date of this Renewal and Amendment No. 1 is July 1, 2013.

IN WITNESS WHEREOF, the parties hereto are in agreement with this Renewal and Amendment No. 1 on the basis set forth in this document and have executed this Renewal and Amendment No. 1 on the day and year set forth herein.






