

**Amendment No. 8**  
**FOR PROFESSIONAL SERVICES AGREEMENT**  
**BETWEEN Press Ganey Inc (Formally known Morehead Associates Inc) AND**  
**THE NATIVIDAD MEDICAL CENTER**  
**FOR**  
**Employee Survey Services**

The Amendment No. 8 to Professional Services Agreement ("Agreement"), dated August 1, 2007 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Press Ganey Inc. (Contractor), with respect to the following:

**RECITALS**

**WHEREAS**, the County and Contractor amended the Agreement previously on May 20, 2008 via Renewal and Amendment No. 1, on July 1, 2008 via Renewal and Amendment No. 2, on October 1, 2008 via Renewal and Amendment No.3, on July 1, 2009 via Renewal and Amendment No. 4, on July 1, 2010 via Renewal and Amendment No. 5, on July 1, 2011 via Renewal and Amendment No. 6, and on July 1, 2013 via Amendment No. 7; and

**WHEREAS**, the County and Contractor wish to amend the Agreement to extend the term end date to allow for existing services to continue.

**AGREEMENT**

1. Section 3. "TERM OF AGREEMENT" shall be amended by removing, "*The term of this Agreement is from August 1, 2007 to June 30, 2008 unless sooner terminated pursuant to this Agreement*" and replacing it with "*The term of this Agreement is from August 1, 2007 to December 31, 2014 unless sooner terminated pursuant to this Agreement.*"
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Renewal and Amendment Nos. 1, 2, 3, 4, 5, 6, and Amendment Nos. 7 are unchanged and unaffected by this Amendment No. 8 and shall continue in full force and effect as set forth in the Agreement.
3. A copy of this Amendment No. 8 and all previous amendments shall be attached to the original Agreement No. (A-12062/MYA599)
4. The effective date of this Amendment is July 1, 2014.


