WHEREAS, *Terry L. Spitz* has worked in the Monterey County District Attorney's Office for 35 years, beginning on February 24, 1979, as a Deputy District Attorney I. He quickly excelled through the ranks, promoting on June 30, 1979, to Deputy District Attorney II; on May 31, 1980, to Deputy District Attorney III; and on December 26, 1981, to Deputy District Attorney IV; and to Assistant District Attorney, on November 20, 1999. On February 26, 2001, *Terry L. Spitz* was appointed to Chief Assistant District Attorney, the position he held until his retirement; and

WHEREAS, in 1990, *Terry L. Spitz* was named one of the most effective prosecutors in the state of California by the *California Lawyer* magazine. In 1995, he was named Monterey County Employee of the Year for his work involving gang prosecutions. In 1997, he was the first attorney ever to be honored by the Monterey County Peace Officers Association, receiving the *Award of Excellence* for his work with a multi-agency task force. In 2013, he was the recipient of the Monterey County Bar Association's *Lewis L. Fenton Award for Excellence in Advocacy*; and

WHEREAS, *Terry L. Spitz* was the first graduating *summa cum laude* from Claremont McKenna College, with a degree in Political Science; received his Juris Doctorate degree from the University of California, Berkeley; was an Honors Graduate of the United States Army Judge Advocate General's School at the University of Virginia and an Honors Graduate of the Defense Language Institute at the Presidio of Monterey in German; and

WHEREAS, *Terry L. Spitz* has provided over three decades of dedicated service to Monterey County and greatly contributed to the quality and success of the District Attorney's Office, served as the District Attorney's designee on various matters, has authored articles in California District Attorney Association's publications and served as an instructor and a longstanding member of the Legislative Committee, and has consistently exemplified the qualities and traits of a professional; and

WHEREAS, *Terry L. Spitz* will enjoy his retirement spending time with his wife Julie, and venturing into the vast wilderness areas which he has not yet explored.
