### **SECTION 5:**

If an application is approved, the Governing Body authorizes and directs the Director of the Department of Public Works, Facilities and Parks of the County of Monterey (the "Funds Request Signer") or Designee (the "Funds Request Designated Signer") to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
