**AMENDMENT No. 1
TO STANDARD AGREEMENT
COUNTY OF MONTEREY
AND
SAN MIGUEL GARBAGE CO., INC.**

THIS AMENDMENT NO. 1 to the Standard Agreement, Agreement No.: A-14247, between the County of Monterey, a political subdivision of the State of California (“County”) and San Miguel Garbage Co., Inc. (hereinafter, “Contractor”) is hereby entered into between the County and the Contractor (collectively, the “Parties”) and effective as of the last date opposite the respective signatures below.

WHEREAS, the Parties entered into a Standard Agreement on March 1, 2019 (the “Agreement”) to allow Contractor to provide solid waste containers, and solid waste and recycling collection services at Lake Nacimiento (the “Services”); and

WHEREAS, the Parties wish to further amend the Agreement to extend to increase the not to exceed amount; and

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Section 2.0, “PAYMENT PROVISIONS” shall be deleted in its entirety and replaced with “County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$417,568.80”.
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
3. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
