AMENDMENT # 1 to AGREEMENT # A-12785

McWilliams-Mailliard Technology Group, Inc.

This Amendment is made and entered into by and between the County of Monterey, a political subdivision of the State of California, (hereinafter, "COUNTY"), and McWilliams-Mailliard Technology Group, Inc. (hereinafter, "CONTRACTOR").

This Amendment modifies the agreement for licenses and subscriptions to the AACTS software for Adult Protective Services staff between the parties executed on July 29, 2014 (hereinafter, "Original Agreement ") by **adding \$9,250 to fund four (4) additional AACTS licenses and provide on-site user training for a maximum of ten (10) end users effective March 1, 2015 through June 30, 2015; and extending the contract term through June 30, 2016, adding \$15,960 for FY 2015/16, increasing the total contract amount to \$38,560.** Therefore, the parties agree:

1. Section 2.0 PAYMENT PROVISIONS of the Original Agreement is amended to read as follows:

2.01 COUNTY shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A subject to the limitations set forth in this Agreement. The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of **\$38,560.**

2. Section 3.0 TERM OF AGREEMENT is amended to read as follows:

3.01 The term of this Agreement is from July 1, 2014 to **June 30, 2016** unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both CONTRACTOR and County, and with County signing last, and CONTRACTOR may not commence work before County signs this Agreement.

3. Section 4.0 of the Original Agreement SCOPE OF SERVICES AND ADDITIONAL PROVISIONS is amended to read as follows:

4.01 The following attached exhibits are incorporated herein by reference and constitute a part of this Agreement:

4. Section I of Exhibit A of the Original Agreement is rescinded, and replaced with Section II, attached.

If there is any conflict or inconsistency between the provisions of the AGREEMENT, or this AMENDMENT, the provisions of this AMENDMENT shall govern. A copy of this AMENDMENT shall be attached to the original AGREEMENT, as it may have been previously amended.

Except as provided herein, all remaining terms, conditions, provisions, entitlements and obligations of the original AGREEMENT shall remain unchanged and unaffected by this AMENDMENT and shall continue in full force and effect.






