# **RECOMMENDATIONS:**

It is recommended that the Board of Supervisors:

- a. Approve Utility Agreement No. 2205-1 with AT&T California for the relocation of underground telephone lines into the proposed bridge conduit for 100% of the actual net cost to AT&T California estimated to be in the amount of \$13,230.00 for the construction of Lonoak Road Bridge Project; and
- b. Authorize the Director of Public Works to execute Utility Agreement No. 2205-1 and future amendments that do not significantly alter the scope of work.

# **SUMMARY/DISCUSSION:**

Approval of the Utility Agreement No. 2205-1 with AT&T California (AT&T) provides relocation of telephone lines for the construction of Lonoak Road Bridge Project. The utility lines will be placed into underground conduit and into a utility conduit within the proposed bridge. AT&T has prior property rights in this area. Monterey County will provide the funds through this agreement to AT&T for the utility relocation during construction of the bridge.

The Resource Management Agency - Department of Public Works, in conjunction with San Benito County, proposes to construct the Lonoak Road Bridge at Lewis Creek for replacement of the existing Lonoak Road Bridge under the California Seismic Retrofit Program. The bridge is located approximately 820 ft northeast of the intersection of Lonoak Road and Highway 25, on the boundary between Monterey and San Benito Counties at the center of Lewis Creek (18.5 km east of King City in Monterey County in Section 13 of Township 19 South, Range 9 East, Mount Diablo Meridian). The proposed bridge will be a two-lane concrete box girder bridge with two spans and a total length of 152.24 feet and a width of 34.35 feet. Monterey County will administer the funding for the project under cooperative agreement with San Benito County through the Federal Highway Bridge Program (HBP) and the State Highway Account (SHA).

#### **OTHER AGENCY INVOLVEMENT:**

County Counsel, Risk Management, Auditor-Controller, and Contracts/Purchasing Offices have reviewed and approved Utility Agreement No. 2205-1 as to form, insurance, and fiscal provisions, respectively.

## **FINANCING:**

There is no financial impact to the General Fund. This report recommends approval of the actual net cost agreement estimated to be \$13,230.00 for Utility Agreement No. 2205-1. The AT&T utility relocation cost is not covered by franchise agreement and Monterey County is responsible for compensating AT&T for this cost, which is represented by the Road Fund.

Complete funding has been programmed for design, environmental, right-of-way and construction costs. The total estimated cost of the project is \$3,480,000. Authorization for Utility Relocation will be obtained upon execution of the Agreement. The \$13,230.00 required for the AT&T utility agreement will be provided by the Federal Highway Bridge Program (HBP) funds of \$11,712.00 (88.53%) and State seismic retrofit funds of \$1,518.00 (11.47%).
