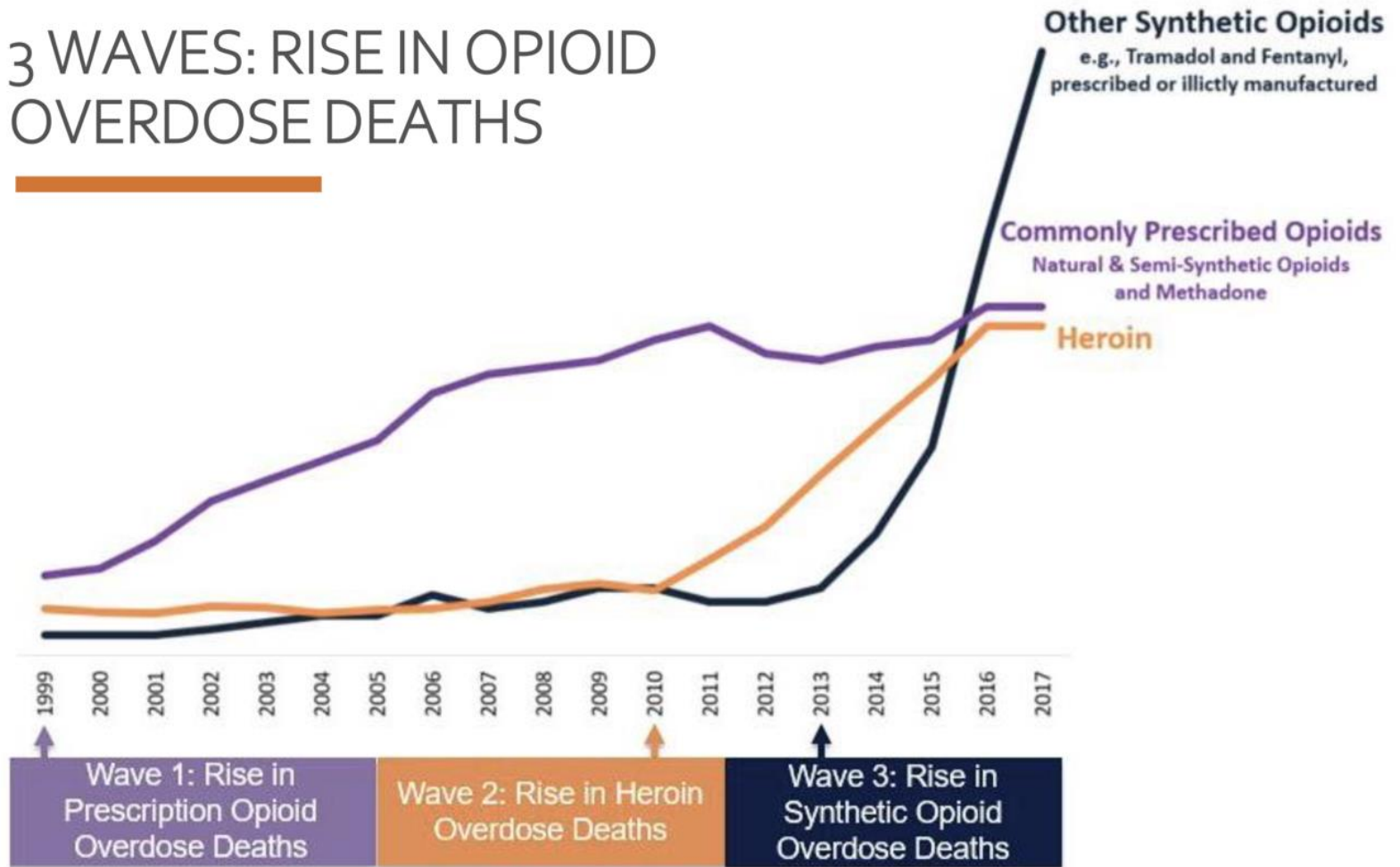

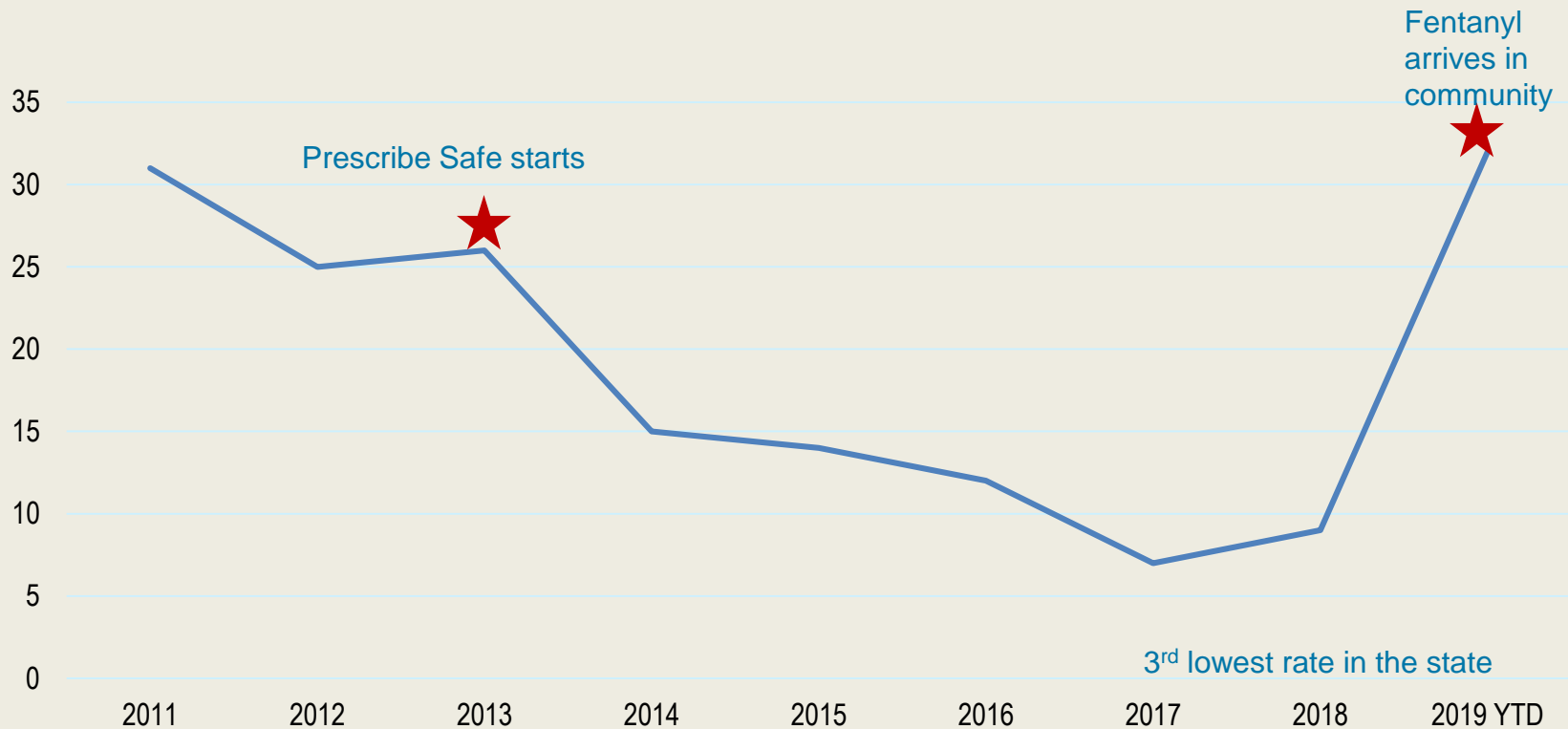

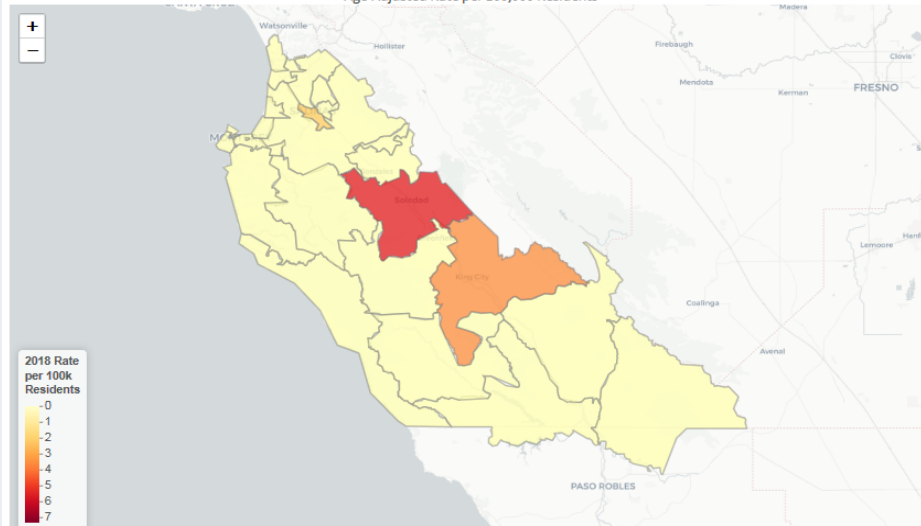

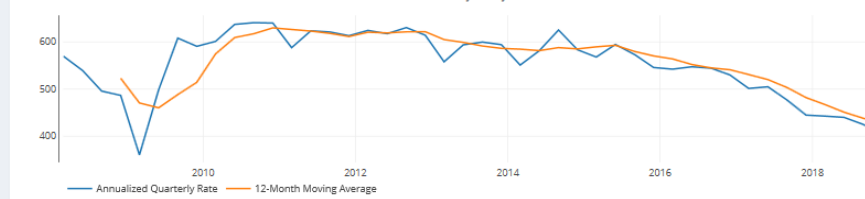

Age-Adjusted Rate per 100,000 Residents



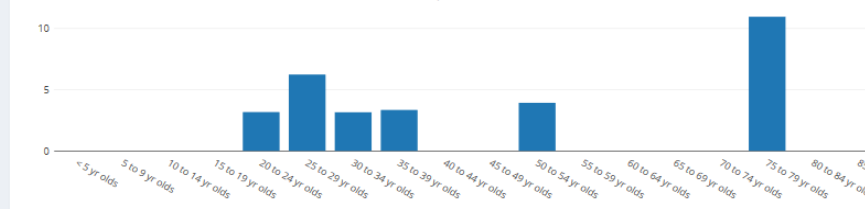
Graph Table Select Display Options Time

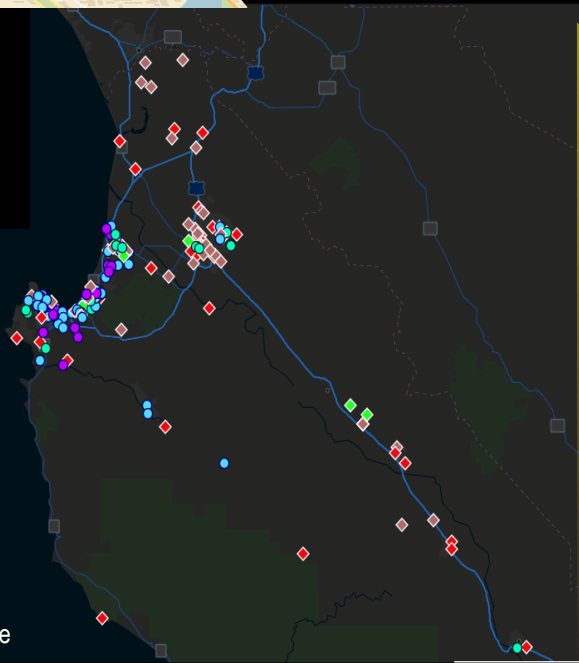

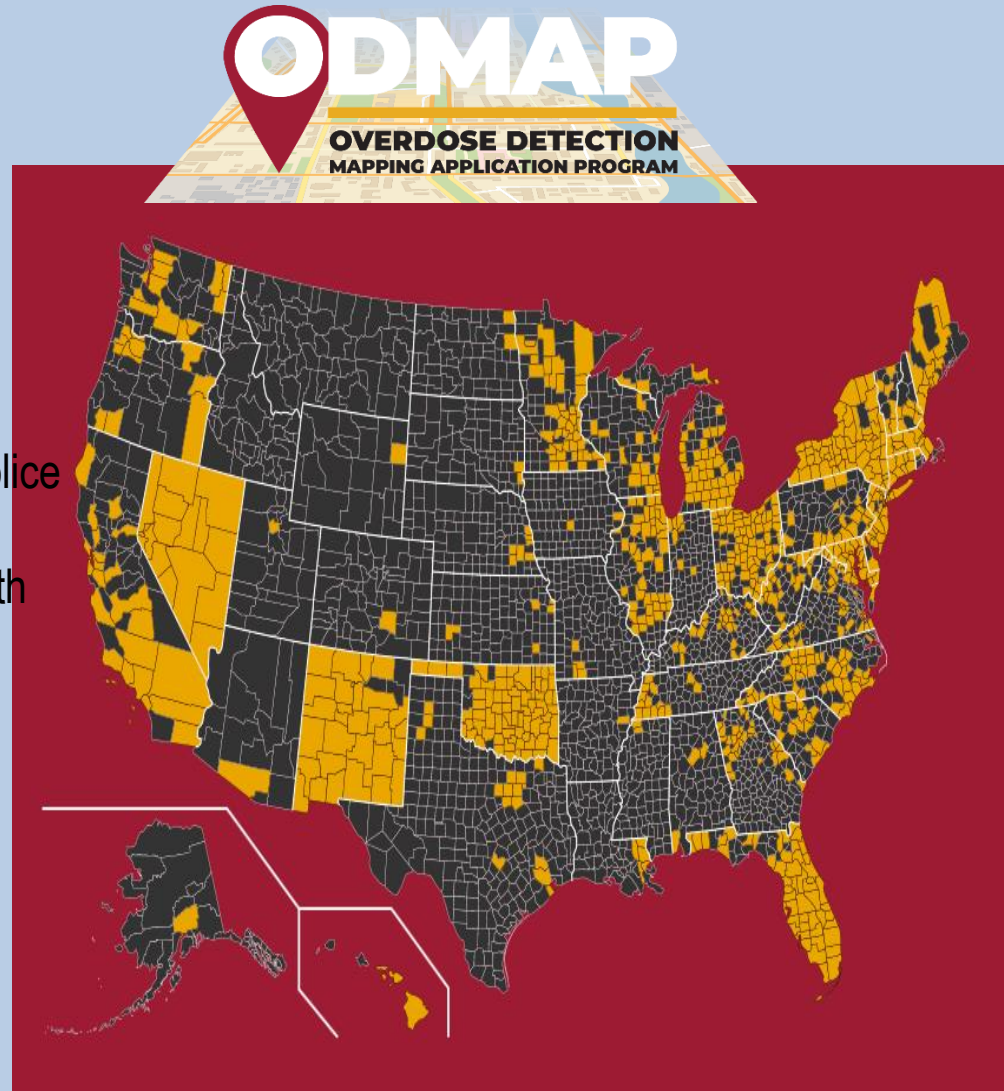
