WHEREAS, Measure AA, is a 1% general sales tax approved by voters in November 2024 that supports services and capital projects in the unincorporated areas of the County.

WHEREAS, the Board established an Ad Hoc Committee to review potential projects and develop funding recommendations consistent with the measure's intent. To ensure ongoing oversight and long-term implementation, the Board transitioned the Ad Hoc Committee into a Standing Committee at the end of 2025.

WHEREAS, In August 2025, the Board reaffirmed its FY 2025–26 Budget Priorities and directed that emphasis be placed on highly visible community-impacting projects, including roads, parks, and homelessness initiatives. In December 2025, the Standing Committee reviewed eligible projects and developed funding recommendations aligned with those priorities. The recommendations were organized in two tiers: (1) projects fully fundable and anticipated for completion within the fiscal year, and (2) projects to proceed as additional funding becomes available.

WHEREAS, On February 3, 2026, the Board approved Tier 1 projects with modifications, including moving the Vierra Canyon Road and Blackie Road projects to Tier 2; allocating \$1.6 million to the Dolan Road project (approximately 2.2 miles), with an additional \$600,000 in upcoming Measure AA revenue to complete the repairs. The Board also authorized Tier 2 projects to proceed as funds become available or if Tier 1 projects are completed under budget.

WHEREAS, based on the Measure AA received an unallocated balance of \$ 13,700,000, the County Administrative Office recommends that:

- (1) CAO17 Fund 001 appropriations be increased by \$13,700,000;
- (2) PFP004 Fund 002 appropriations be increased by \$10,800,000;
- (3) PFP067 Fund 453 appropriations be increased by \$300,000
- (4) PFP058 Fund 001 appropriations be increased by \$2,400,000;
- (5) And HCD002 Fund 001 appropriations be increased by \$200,000 to complete projects identified by the Measure AA Standing Committee.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Monterey, does hereby approve as follows:

 6. Increase appropriations by \$10,800,000 in Road Fund 002, Roads and Bridges Appropriation Unit PFP004, financed by an Operating Transfer in from General Fund 001, Other Financing Uses Appropriation Unit CAO017;
 7. Increase appropriations by \$300,000 in Laguna Seca Recreation Area Fund 453, Appropriation Unit PFP067, financed by an Operating Transfer in from General Fund 001, Other Financing Uses Appropriation Unit CAO017;
 8. Transfer \$10,800,000 from General Fund 001, Other Financing Uses Appropriation Unit CAO017, to Roads Fund 002, Road and Bridges Appropriation Unit PFP004;
 9. Transfer \$300,000 from General Fund 001, Other Financing Uses Appropriation Unit CAO017, to Laguna Seca Recreation Area Fund 453, Appropriation Unit PFP067;
 10. Transfer \$2,400,000 from General Fund 001, Other Financing Uses Appropriation Unit CAO017, to General Fund 001, Recreation Services Appropriation Unit PFP058; and
 11. Transfer \$200,000 from General Fund 001, Other Financing Uses Appropriation Unit CAO017, to General Fund 001, Community Development Appropriation Unit HCD002.

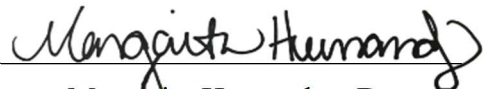
