

Project Description



Background

- Annexed into the City of Salinas in 1963
- 2.75 square miles
- Approximately 30% of the City's population

Project Status

- Feb 2020 City of Salinas (City) releases the Final Copy of the Alisal Vibrancy Plan (AVP)
- Nov 2024 City adopted the Alisal District Identity Master Plan (ADIMP)
 - AVP and ADIMP identifies locations for potential gateway/placemaking signage
 - Location and designs have not been specifically identified
- Oct 2025 City staff to develop a draft process, timeline and staffing resources for developing and delivering gateway/placemaking signage
 - Process would include additional community engagement and RFP for artist to design the gateway element



City has appropriated \$348,104 for gateway/placemaking signage but not specifically for an arch

Potential Funding Contributions (funding source and availability TBD)

Option 1 – Percentage of the City's gateway/placemaking signage appropriation (\$348K)

- a) 10% = \$34,810
- b) 20% = \$69,621
- c) 30% = 104,431
- d) 40% = 139,242
- e) 50% = \$174,052

Option 2 – Percentage of the 2021 Salinas Arc Project Cost (\$525K)

- f) 10% = \$52,500
- g) 20% = \$105,000
- h) 30% = \$157,500
- i) 40% = 210,000
- j) 50% = \$262,500

Option 3 – Launch a one-year fundraising campaign

Option 4 – Combine Options 1 & 3 or 2 & 3 (correction from staff's report)
