**Background.** This is Amendment #4 ("Amendment") to the EndoTool Glucose Management System Subscription Contract dated October 2, 2018 between Monarch Medical Technologies LLC ("Company") and County of Monterey on behalf of Natividad Medical Center, ("Customer"). Customer and Company wish to enter into this Amendment #4 as of the Amendment Effective Date set forth above ("Effective Date").

Except as provided herein, all remaining terms, conditions, and provisions of the original Contract are unchanged and unaffected by this Amendment #4 and shall continue in full force and effect as set forth in original Contract, Amendment #1, Amendment #2, and Amendment #3.

**Renewal.** Customer wishes to renew the Contract for three (3) years beginning on January 30, 2026 continuing through January 29, 2029 for a full revised Agreement term (October 2, 2018 through January 29, 2029). The Annual Subscription Fees for that period are set forth on Exhibit A to this Amendment, replacing any previous Exhibit A's from prior agreements. This renewal is only EndoTool IV and EndoTool Analytics.

**Previous Annual Use Period.** The parties acknowledge that all Annual Subscription Fees for all previous Annual Use Periods have been paid in full.

**Effect of Amendment.** Unless expressly modified by this Amendment, all capitalized terms herein have the meanings provided in the Contract. Except as modified by this Amendment, all terms and conditions of the Contract remain unchanged and in full force and effect. If this Amendment and the Contract are inconsistent, this Amendment supersedes the Contract to the extent necessary to satisfy the purpose of this Amendment.




