**WHEREAS, Investigative Sergeant Terry Kaiser** was hired by the Monterey County Sheriff's Office on September 10, 1970; and

**WHEREAS, Investigative Sergeant Terry Kaiser** was born in Oakland, California, raised in a military family traveling between the United States and Europe and attended both Monterey and Seaside High Schools; and

**WHEREAS, Investigative Sergeant Terry Kaiser** joined the United States Navy in 1964 through 1967 during the Vietnam War where he was stationed on the USS Hancock CV-19 in the South China Seas as a Petty Officer Third Class Cryptology Technician assigned to Naval Security Group Activity where the ship received the Naval Unit Commendation for outstanding record for combat strikes on Communist positions and upon returning home from his service in the United States Navy enrolled and graduated from Hartnell College; and

**WHEREAS, Investigative Sergeant Terry Kaiser** was sworn in on September 10, 1970 by Sheriff Jack Davenport and over his forty-eight and a half years of service he served seven Monterey County Sheriffs: Jack Davenport, D.B. "Bud" Cooke, Norman G Hicks, Gordon Sonn , Mike Kanalakis, Scott K. Miller and Steve Bernal; and

**WHEREAS, Investigative Sergeant Terry Kaiser** served as a Corrections Deputy, Patrol Deputy, Sheriff's First SWAT Team member, Investigative, Patrol Sergeant, and a Investigative Sergeant and he attended the FBI National Academy Number 204 and he was assigned to the United States President protection details for Presidents Richard Nixon, Gerald Ford, Ronald Reagan, Bill Clinton, and George H.W. Bush Sr., and he was assigned to FBI Taskforce-6 for Organized Crime in which several were confidential cases, and supervised the very first Methamphetamine Clandestine Laboratory Team; and

**WHEREAS, Investigative Sergeant Terry Kaiser** retires as a Investigative Sergeant in where he supervised for the past 38 and a half years multiple Investigation cases related to Homicides, Narcotics, Gangs, Stolen Vehicles, Burglaries, Weapons, and Agriculture related crimes; and

**WHEREAS, Investigative Sergeant Terry Kaiser** over his long career received many letters of appreciations and commendations from citizens, staff, community organizations and law enforcement agencies commending his exceptional work, team work and community commitment.
