### Other Board Matters

Supervisor Jane Parker and Supervisor John M. Phillips made no comments this week.

Supervisor Luis A. Alejo reported last night they had coffee on the East side that went well at La Plaza Bakery; there were several dozen residents present that spoke primarily Spanish so the meeting was held in Spanish but there was English translation; it was in partnership with the City of Salinas to refocus conversations on roads, street lights, sidewalks among other things; he clearly heard from a lot of residents that have been neighborhood leaders for many years they're really hoping to see that with the new Measure X money the new SB1 money that the poorest neighborhoods in Salinas can actually see the fruition of many of the requests after many years that there be some investment in paving roads and constructing sidewalks and replacing lights; the City of Salinas is going to consider approving it's 2 year process on the Alisal Vibrancy Plan; it's going to be put into a final document on May 14th but certainly there's been a lot of community input and now it's hard work of implementing those ideas so he really hopes that we can do justice to the poorest neighborhoods in our city same goes for the parts of a county that have been waiting for a long time that if we get new resources that we could prioritize those communities that have been waiting for the longest time.

Supervisor Mary L. Adams commented she had the pleasure of attending a National Association of Counties meeting in Washington, D.C. with Supervisor Alejo and Supervisor Lopez; they had some extremely good meetings both with our congress representative and senators; she thought the primary thing that was really positive about it as they had a chance to meet with Department of Commerce and specifically with the Census Bureau to be able to talk about some of the issues that we face here in Monterey County as a "difficult to count community" they brought some attention to their awareness which is important and made some very good connections with them; she believed they understood what our concerns are; secondly she had the opportunity yesterday evening to participate in the town hall meeting with Sheriff Bernal and Commander Kelly Cardoza, of the California Highway Patrol, meeting with residents in a Toro Park area talking primarily about concerns that they have for traffic that diverts itself from Highway 68 and goes through the neighborhoods where there a lot of kids who are walking to school; it was a very good meeting and she thought they were able to hear a lot from the residents who live there; they came up with a couple of solutions that will be brought forward and she hoped that they can do something to mediate the



concerns that they have.

Supervisor Chris Lopez wanted to bring a couple of different dates to everybody's attention, Friday March 15th at 6:00 p.m. he'll host a listening session in San Ardo talking about sidewalks, street lights and some basic services in that community so that's this Friday at 6:00 p.m.; on March 21st there will be another meeting regarding Lake San Antonio held in Lockwood at the community center at 6:00 p.m. and the following meeting March 22nd will be the Annual SMCRC which stands for Southern Monterey County Rural Coalition town hall; he'll be there the next evening as well taking input and then on March 27th he'll hold a community meeting in Arroyo Seco primarily regarding community safety based around the summer months and the visitorship on that side of Los Padres National forest.
