WHEREAS the County of Monterey has received an award in the amount of \$35 Million from BSCC as contribution to the construction of a 120-medium-security-bed facility;

WHEREAS the BSCC has approved the Project's Scope, Cost, and Schedule for the County of Monterey's new Juvenile Hall;

WHEREAS the County of Monterey is required to submit an Operational and Staffing Plan to BSCC for State approval in order to meet project milestones;

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors does hereby:

- a. Approve the Operational and Staffing Plan for the New Juvenile Hall Project No. 8811;
- b. Authorize submittal of the approved Operational and Staffing Plan to the Board of State and Community Corrections for State approval; and
- c. Authorize and direct the County Administrative Officer, Resource Management Director, and Chief Probation Officer to take such other further actions as may be necessary or appropriate to meet State milestone requirements as defined under the SB 81 2007 Youthful Offender Rehabilitative Facility Financing Program.
