AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT (PSA)

between

MONTEREY COUNTY PROBATION DEPARTMENT and COMMUNITY HUMAN SERVICES

THIS AMENDMENT NO. 3 to PSA dated June 15, 2010 is made and entered into by and between Community Human Services, hereinafter called "Contractor", and Monterey County, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and Contractor have heretofore entered into a Professional Services Agreement dated June 15, 2010 (hereafter "PSA");

WHEREAS, the County and Contractor amended the Agreement previously on August 17, 2010 via Amendment No.1; September 20, 2011 via Amendment No.2; and

WHEREAS, the County and Contractor mutually desire to continue services providing family counseling, and treatment services for juveniles participating in the Juvenile Justice Crime Prevention Act (JJCPA) programs.

WHEREAS, the County and Contractor wish to modify the Agreement for services to extend the term date and increase the PSA amount by \$40,654.00 for the period of July 1, 2012 through June 30, 2013, for a total agreement amount not to exceed \$121,962.00.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein and in the PSA, the parties agree as follows:

- 1. Item 2, **Payments by County** of Agreement is amended to read as follows: "County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set for in this Agreement. The total amount payable by County to CONTRACTOR under Agreement shall not exceed the sum of \$121,962.00."
- 2. Item 3, **Term of Agreement** is amended to read as follows: "The term of this Agreement is from July 1, 2010 to June 30, 2013 unless sooner terminated pursuant to the terms of this Agreement"
- 3. Except as herein stated, all other terms, provisions and exhibits of the PSA shall remain in full force and effect.
- 4. A copy of this Amendment shall be attached to the original PSA dated June 15, 2010.
- 5. Except as herein stated, all other terms, provisions and exhibits of the PSA shall remain in full force and effect.
