WHEREAS, California Clinical Forensic Medical Training Center (CCFMTC) is the correct name of the organization that offers Sexual Assault Forensic Examiner training; and adding the language "other pre-approved providers" will permit the department to utilize organizations approved by the Sexual Assault Response Team Coordinator (SART) to provide the same training;

WHEREAS, the requirement to have served as a Sexual Assault Forensic Examiner ("SAFE") for one year prior to being eligible to receive the training stipend for Pediatric Examinations is no longer applicable;

WHEREAS, the deletion of the language in reference to the distinction between licensure and type of training taken, is no longer applicable since the training is only offered in-person;

WHEREAS, the actions require the Personnel Policies and Practices Resolution No. 98-394, Section A.48.3 Sexual Assault Forensic Examiner – Per Diem language to be amended; NOW, THEREFORE,

BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:

1. Section A.48.3 Sexual Assault Forensic Examiner – Per Diem, of Personnel Policies and Practices Resolution No. 98-394 is amended as indicated below;

Upon proof of completion of training provided by California Clinical Forensic Medical Training Center (CCFMTC) or other pre-approved provider, SAFE's shall be eligible for reimbursement for such training up to the following amounts:

\$500 for training - Conducting Adult Examinations

\$500 for training - Conducting Pediatric Examinations.

2. The Human Resources Department is hereby authorized to implement these changes.
