A Resolution of the Board of Supervisors of the County ) of Monterey Rescinding Resolution No. 14-285......)

**WHEREAS**, on October 7, 2014, the County of Monterey ("County"), as an affected taxing entity, held a public meeting to consider the public benefit and public purpose of the Steinbeck Center and a new campus of the California State University, Monterey Bay in Downtown.

WHEREAS, after said public meeting, the County adopted Resolution 14-285, agreeing to forgive and forgo the receipt of unanticipated revenue that would have come to it from the proceeds of the sale of the National Steinbeck Center to the California State University, Monterey Bay; and

WHEREAS, the Salinas Oversight Board said Resolution to the State Department of Finance ("DOF"); and

WHEREAS, the DOF rejected the concept of "forgiveness" of debt and required that sale proceeds be processed through the procedure laid out in the Dissolution Act (Health and Safety Code §§ 34161 *et seq.*); and

WHEREAS, the County will be entering into a Memorandum of Agreement with the National Steinbeck Center ("NSC"), agreeing to pay to the NSC the County's share of proceeds from the sale of the NSC to the California State University, Monterey Bay; and

WHEREAS, the Memorandum of Agreement supplants and replaces Resolution 14-285.

**NOW THEREFORE, BE IT RESOLVED**, that the County of Monterey hereby RESCINDS Resolution 14-285.

This Resolution shall take effect immediately.

# MEMORANDUM OF AGREEMENT BETWEEN THE NATIONAL STEINBECK CENTER AND THE COUNTY OF MONTEREY

This MEMORANDUM OF AGREEMENT ("AGREEMENT") is made on Market 24, 2015, by and between the National Steinbeck Center ("NSC"), and the County of Monterey ("COUNTY").

### RECITALS

- A. The County of Monterey ("County") is considered an "affected taxing entity" under the Community Redevelopment Law (Health and Safety Code sections 33000, et seq.), with regard to the Project Area; and
- B. Effective June 29, 2011, the Community Redevelopment Law was significantly amended by the Dissolution Act (ABX 1 26), which had the effect of dissolving redevelopment agencies and requiring that assets and debts of redevelopment agencies be liquidated and funds transferred to "affected taxing agencies;" and
- C. On October 7, 2014, the County adopted Resolution 14-285, to support establishing a California State University of Monterey Bay campus in downtown Salinas and to forgo the receipt of unanticipated tax revenue of approximately \$68,264.00 from the sale of the Steinbeck Center to California State University Monterey Bay; and
- D. The County has been informed that the State Department of Finance has required the reallocation of sales proceeds rather than their "forgiveness;" and
- E. The County of Monterey wishes to reconfirm its intent to forgo the County's share of un-anticipated tax revenue, as well as its determination that sale of the Steinbeck Center to California State University Monterey Bay is in the "best interests" of the Steinbeck Center, the City of Salinas' Downtown Vibrancy Plan and educational interests of California State University, Monterey Bay, and ultimately, the County's best interests.

## NOW THEREFORE, IT IS MUTUALLY AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:

### **AGREEMENT**

### 1. Sale Proceeds Collection and Remittance

Within 10 business days of receipt of its share of the proceeds of the sale of the National Steinbeck Center to California State University Monterey Bay, the County shall remit the same

to the National Steinbeck Center, at the following address:

- 2. <u>Amendment by Written Recorded Instrument</u>. This Agreement may be amended or modified in whole or in part, only by written instrument executed by both of the parties.
- 3. <u>Governing Law.</u> This Agreement shall be governance by and interpreted by and in accordance with the laws of the State of California
- 4. <u>Interpretation.</u> It is agreed and understood by the parties hereto that this Agreement has been arrived at through negotiation and the neither party is to be deemed the party which prepared the Agreement within the meaning of Civil Code Section 1654.
