WHEREAS, Joan L. Nugent was selected to remain as Principal of the newly reconfigured school, renamed Seaside Middle School in July of 2010, and has continued in her role as Principal for one of the longest terms at a single site in the district; and

WHEREAS, Joan L. Nugent made many contributions to the success of Seaside Middle School, where she was considered an exceptional leader by her staff, and has been a respected professional in the education field; and

WHEREAS, Joan L. Nugent was one of the pioneers in the district to advocate for the comprehensive, daily use of technology in education, supplying each classroom at her site with an array of devices to be used for student engagement and success; and

WHEREAS, Joan L. Nugent was a strong activist in creating the optimal learning environment for ALL students by selecting competent and diverse staff members, by creating a structure where English Learners and students receiving special services could achieve success, and by improving the positive climate of the school through evidence-based behavioral practices; and

WHEREAS, Joan L. Nugent was a tireless advocate for the arts, creating the largest and most diverse visual and performing arts department at the middle school level in the district that has offered classes in theatre, drawing, painting, ceramics, vocal and instrumental music, and dance; and

WHEREAS, Joan L. Nugent's strong passion and commitment to the students of Monterey Peninsula Unified School District has touched the lives of families for many years to come, and she will be deeply missed.
