Upon motion of Supervisor Alejo, seconded by Supervisor Salinas and carried by those members present, the Board of Supervisors hereby:

- a. Authorized the Deputy Purchasing Agent for Natividad Medical Center (NMC) or his designee to execute amendment No. 1 to the agreement with CALSTAR Air Medical Services, LLC (formerly California Shock Trauma Air Rescue) for patient transfer coordination and facilitation services, extending the agreement an additional three (3) year period (December 15, 2017 through December 14, 2020) for a revised full agreement term of December 15, 2014 through December 14, 2020, and adding \$450,000 for a revised total agreement amount not to exceed \$550,000.
- b. Authorized the Deputy Purchasing Agent for NMC or his designee to execute up to three (3) future amendments to the agreement which do not significantly alter the scope of work and do not cause an increase of more than ten percent (10%) (\$10,000) of the original cost of the agreement per each amendment.

# AMENDMENT NO. 1 TO SERVICES AGREEMENT BETWEEN CALIFORNIA SHOCK TRAUMA AIR RESCUE (CALSTAR) AND NATIVIDAD MEDICAL CENTER FOR

### PATIENT TRANSFER COORDINATION AND FACILITATION SERVICES

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on December 15, 2014 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and CALSTAR Air Medical Services LLC (CALSTAR) through its All-Access Transfer Center ("A-ATC") (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

#### RECITALS

WHEREAS, the Agreement was executed for Patient Transfer Coordination and Facilitation Services with a term December 15, 2014 through December 14, 2017 and a total Agreement amount not to exceed \$100,000; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional three (3) year period through December 14, 2020 to allow for services to continue with a \$450,000 increase for a total Agreement amount of \$550,000 (the "Financial Cap").

#### **AGREEMENT**

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement incorporated herein by this reference, except as specifically set forth below.

- The second sentence of <u>Section 2 titled</u>, "PAYMENTS BY NMC" shall be amended to the following: "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$550,000."
- 2. The first sentence of <u>Paragraph titled</u>, "TERM OF AGREEMENT" shall be amended to the following: "The term of this Agreement is from December 15, 2014 through December 14, 2020, our until the date the sum of \$550,000 is earned by CONTRACTOR, whichever date is earlier, unless sooner terminated pursuant to the terms of this Agreement."
- Except as provided herein, all remaining terms, conditions and provisions of the Original Agreement
  are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as
  set forth in the Agreement.
- 4. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
- 5. This Amendment No. 1 shall be effective when signed by both parties.
- NMC and CALSTAR shall work collaboratively to monitor and manage service requests to assure that the Financial Cap is not exceeded during the Term of this Agreement.
- 7. The Fee Schedule in Exhibit A of the Agreement shall be replaced in its entirety with Exhibit A-1 Fee Schedule attached hereto and incorporated herein.

IN WITNESS WHEREOF, the Parties hereto are in agreement with this Amendment No. 1 on the basis set forth in this document and have executed this Amendment No. 1 on the day and year set forth herein.
