WHEREAS, Deputy Paul Bryan Butterfield began his law enforcement career in February of 1995 with the Monterey County Sheriff's Office, after graduating in 1993 from the Central Coast Counties Police Academy in Gilroy; and

**WHEREAS, Deputy Paul Bryan Butterfield** was sworn in on February 21, 1995 by Sheriff Norman G. Hicks; and

WHEREAS, Deputy Paul Bryan Butterfield over his career served five Monterey County Sheriffs: Norm Hicks, Gordon Sonné, Mike Kanalakis, Scott Miller, and Stephen Bernal; and

WHEREAS, Deputy Paul Bryan Butterfield gained respect in all areas that he worked within the Custody Operations Bureau during his tenure with the Sheriff's Office; and

WHEREAS, Deputy Paul Bryan Butterfield worked in the jail until October 12, 1996 when he was transferred to the Enforcement Operations Bureau, then returned to the Custody Operations Bureau on March 15, 1997 and remained working in the jail until February 14, 1998 when he was assigned to the Sheriff's Transportation Unit; and

WHEREAS, On November 3, 2001, Deputy Paul Bryan Butterfield was selected by Judge Susan Dauphine to be her full time Court Bailiff and subsequently was assigned to the Court Security Unit of the Sheriff's Office; and

WHEREAS, Deputy Paul Bryan Butterfield's courtrooms often handled extremely emotional and sometime volatile calendars but he always maintained a safe, secure, and calm courtroom; and

WHEREAS, On October 22, 2002 Deputy Paul Bryan Butterfield received a memorandum of appreciation from Sheriff Gordon Sonné for the help he provided during a retiree event; and

WHEREAS, On April 30, 2004, Deputy Paul Bryan Butterfield received a letter of commendation from Sheriff Mike Kanalakis for the invaluable assistance he provided the Office during a notorious jail disturbance because his actions, as well as the actions of other deputies from various Bureaus and Divisions working cohesively, played a vital role in restoring order in the county jail without incurring injuries to the deputies and keeping inmate injuries to a minimum; and
