**WHEREAS, Gail T. Borkowski** served as the Court Supervisor in the Juvenile Division with the Superior Court in the County of Santa Cruz from 1997 to 2000; and

**WHEREAS, in August 2000, Gail T. Borkowski** began her tenure as the Chief Deputy Clerk of the Board of Supervisors in the County of Santa Cruz, further serving the residents of Santa Cruz County; and

**WHEREAS, in July 2007, Gail T. Borkowski** began serving as the City Clerk for the City of Sunnyvale; and
