

Amendment 1 To Agreement 00282609.0



County of Monterey ("County") and **Environmental Systems Research Institute, Inc.** ("Esri") have entered into Enterprise Agreement number 00282609.0 ("EA") on June 2, 2020. The parties now amend the EA to extend the period of performance and to update product list and pricing, as follows:

- 1. Effective Date.** The Effective Date of the EA is changed from June 2, 2020 to July 16, 2020.
- 2. Article 7.1 Term.** The term of the EA is extended three additional years beginning on July 16, 2023 and expiring on July 15, 2026 unless this EA is terminated earlier as provided herein.
- 3. Appendices.** For the extended term beginning on July 16, 2023 and expiring on July 15, 2026, Appendix A—Products and Deployment Schedule and Appendix B—EA Fee Schedule are updated with new appendices, both attached hereto and incorporated herein by reference.
