EASEMENT RELOCATION AGREEMENT

COUNTY OF MONTEREY, a body politic and corporate, hereinafter called first party, makes this agreement with PACIFIC GAS AND ELECTRIC COMPANY, a California corporation, hereinafter called second party, for the purpose of changing the location of the right of way and easement within portions of the strips of land described and designated PARCEL ONE and PARCEL TWO in the deed from County of Monterey to Pacific Gas and Electric Company dated January 29, 1980 and recorded in Reel 1391 at page 364, Records of the County of Monterey, State of California, under and by virtue of which second party is the owner of certain rights in, on, over, and across the lands, situate in the City of Salinas, said County of Monterey, described in said deed dated January 29, 1980.

NOW, THEREFORE, the parties hereto agree that the location of the right of way and easement within those portions of said strips of land shown as being relocated upon Grantee's Drawing No. 14-3-451S be, and it hereby is, changed to the strips of land described as follows:

The strips of land of the uniform width of 10 feet, lying 5 feet on each side of the alignment of the facilities as initially installed hereunder. The approximate locations of said strips are shown upon Grantee's Drawing No. 14-3-451S attached hereto and made a part hereof.

As so modified the rights granted by said deed dated January 29, 1980 are hereby confirmed in second party on the terms and conditions therein set forth.


This agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which, together, shall constitute one and the same instrument.
