Adopt Resolution **Commending Sergeant Jasper DeFranco** Upon His Retirement from Thirty Years of Public Service with the Monterey County Sheriff's Office.

WHEREAS, Sergeant DeFranco was born in Monterey, California, and graduated Monterey High School in 1980 and subsequently received a certificate of achievement in Administration of Justice at Monterey Peninsula College in 1993; he is the father of 39-year-old Jasper DeFranco Jr., 38-year-old Jeannie DeFranco-Soto, 33-year-old Jonathon DeFranco and grandfather to two beautiful girls and one boy; he currently resides in Hollister; and

WHEREAS, Sergeant DeFranco was sworn in as a Reserve Patrol Deputy by Sheriff Norman G. Hicks in 1994 and later as a Deputy Sheriff-Corrections in 1996; over his career, Sergeant DeFranco served under six Monterey County Sheriffs: Norman Hicks, Gordon Sonne, Mike Kanalakakis, Scott Miller, Steve Bernal, and Tina Nieto; and

WHEREAS, Sergeant DeFranco had demonstrated excellent performance during his tour of duty at the Monterey County Sheriff's Office where he held the positions of Reserve Patrol Deputy (1994), Deputy Sheriff-Corrections (1996), and Sheriff's Sergeant (2003); and

WHEREAS, Sergeant DeFranco served the majority of his 30 years in the Corrections Operations Bureau; he served as a Sheriff's Sergeant for 21 years, being assigned as a Shift Sergeant, a Compliance/Program Sergeant, and a Court Services Unit Sergeant; he was the founding Sergeant for the Jail's Compliance Unit where he serves as a liaison to the Board of State and Community Corrections (BSCC), the liaison to the State Fire Marshal, and the liaison to County Counsel regarding the Hernandez v. Monterey County lawsuit; he created and updated nearly every form used in the Jail facility and created the Jail Intranet website; he became a TracNet Administrator, Telmate Administrator, Telestaff Administrator, Wincams Administrator, Jail SharePoint Administrator, and Lexipol for Corrections Administrator during his tour of duty at the Jail; and

WHEREAS, Sergeant DeFranco plans to enjoy his retirement traveling around the United States as well as Italy, working on home projects, restoring classic cars, and spending as much time as possible with his family.

NOW, THEREFORE BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby acknowledges, commends, and thanks **Sergeant Jasper DeFranco** for his thirty years of exemplary public service to the residents of the County of Monterey, as a valued member of the Monterey County Sheriff's Office.
