

AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE COUNTY OF MONTEREY AND KEYSER MARSTON ASSOCIATES, INC.

THIS AMENDMENT NO. 3 to the Professional Services Agreement between the Successor Agency to the Redevelopment Agency of the County of Monterey, a political subdivision of the State of California ("Agency") and Keyser Marston Associates, Inc. ("CONTRACTOR"), is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") as of the last date opposite the respective signatures.

WHEREAS, CONTRACTOR entered into a Professional Services Agreement with the Agency on March 16, 2018 ("Agreement") to provide financial consulting services ("services") related to the Participation Payment Provision of the East Garrison Disposition and Development Agreement ("Project") through December 31, 2018, for an amount not to exceed \$9,500;

WHEREAS, the Agreement was amended by the Parties on December 18, 2018 ("Amendment No. 1," including Exhibit A-1 – Scope of Services/Payment Provisions) to add Tasks 3 and 4 to the Scope of Services, note completion of Tasks 1 and 2, extend the term of the Agreement for three (3) additional years to December 31, 2021, and to increase the Agreement amount by \$20,000 which resulted in a total not to exceed amount of \$29,500;

WHEREAS, the Agreement was amended by the Parties on November 30, 2021 ("Amendment No. 2," including Exhibit A-2 – Scope of Services/Payment Provisions) to add Tasks 5, through 8 to the Scope of Services, update CONTRACTOR's hourly rates, and extend the term two (2) additional years to December 31, 2023;

WHEREAS, the CONTRACTOR's hourly rates require updating;

WHEREAS, Tasks 1, 2, 5 and 6 are complete, and Task 7 is no longer required;

WHEREAS, the Parties have identified the need to narrow the Scope of Services to Tasks 3, 4 and 8;

WHEREAS, additional time and funding are necessary to allow CONTRACTOR to continue to provide the services required by the Agency for completion of the Project; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term for three (3) additional years to December 31, 2026, and to increase the not to exceed amount of \$52,500 by \$5,250 for a new Agreement amount of \$57,750.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Amend the first sentence of Paragraph 1, "Services to be Provided," to read as follows:
 - The Agency hereby engages CONTRACTOR to perform, and CONTRACTOR hereby agrees to perform, the services described in <u>Exhibits A through A-3</u> in conformity with the terms of this Agreement.
- 2. Amend Paragraph 2, "Payments by Agency," to read as follows:
 - Agency shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibits A through A-3, subject to the limitations set forth in this Agreement. The total amount payable by Agency to CONTRACTOR under this agreement shall not exceed the sum of \$57,750.
- 3. Amend the first sentence of Paragraph 3, "Term of Agreement," to read as follows: The term of this Agreement is from March 1, 2018, to December 31, 2026, unless sooner terminated pursuant to the terms of this Agreement.
- 4. Amend Paragraph 4, "Additional Provisions/Exhibits," to add "Exhibit A-3, Scope of Services/Payment Provisions."
- 5. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.
- 6. This Amendment No. 3 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

To Agreement by and between Successor Agecy to the Redevelopment Agency of the County of Monterey, hereinafter referred to as "Agency"

and

Keyser Marston Associates, Inc., hereinafter referred to as "CONTRACTOR"

A. SCOPE OF SERVICES

- **A.1** CONTRACTOR shall provide services and staff, and otherwise do all things necessary for or incidental to the performance of work, as set forth in the table below:
 - Task 1. Refinements to Participation Manual Complete
 - Task 2. Review of First Progress Report Complete

Task 3. Review of Second Progress Report

When the Second Progress Report is submitted, CONTRACTOR will review the Progress Report, confirm that the necessary documentation has been provided and that the calculations have been made correctly, and report the results to the Agency.

<u>Deliverable</u>: Memorandum summarizing review of the Second Progress Report. Completion dependent on timing of <u>Second Progress Report submittal pursuant to DDA</u>.

Task 4. Final Report

When the Final Report is submitted, CONTRACTOR will review the Final Report, and report the final results to the Agency.

<u>Deliverable</u>: Memorandum summarizing review of the Final Report. Completion dependent on timing of Final Report submittal pursuant to DDA.

- Task 5. Project Launch Complete
- Task 6. Peer Review of Willdan Retail Feasibility Study Complete
- Task 7. Analysis of Residential and Visitor Demand Not Required

Task 8. Summary Memorandum

Develop and submit a Final Memorandum to Agency to include a summary of the findings of the analyses and recommendations.

Deliverable: Final memorandum.

EXHIBIT A-3 – SCOPE OF SERVICES/PAYMENT PROVISIONS

B. PAYMENT PROVISIONS

B.1 COMPENSATION/PAYMENT

Agency shall pay an amount not to exceed \$57,750 for the performance of <u>all things</u> <u>necessary</u> for or incidental to the performance of work as set forth in the Scope of Work. CONTRACTOR's compensation for services rendered shall be based on a time and materials basis according to the following rates or in accordance with the following terms:
