WHEREAS, the Allocation Acceptance Form relates to the availability of the funds under the Program; and

WHEREAS, the County of Monterey was listed as an eligible applicant in the Allocation Acceptance Form, dated October 1, 2021.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Monterey ("County") does hereby determine and declare as follows:

SECTION 1. That County is hereby authorized and directed to apply for and accept County's allocation award, as detailed in the Allocation Acceptance Form (the "HNP Round 2 Allocation Award"), up to the amount authorized the Allocation Acceptance Form and applicable state law.

SECTION 2. That **Lori A. Medina, Director of Social Services,** or her designee, is hereby authorized and directed to act on behalf of County in connection with the HNP Round 2 allocation award and any additional HNP allocation, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to be participate in the Program and be awarded the HNP allocation award and any amendments to such documents (collectively, the "HNP Round 2 allocation award documents").

SECTION 3. That County shall be subject to the terms and conditions that are specified in the HNP Round 2 allocation award documents, and that County will use the HNP 2 allocation award funds and any additional HNP allocation funds in accordance with the allocation acceptance form, the HNP allocation award documents, and any and all other HNP requirements, and other applicable laws.
