**WHEREAS**, the Superior Court's increased usage of the pretrial program has outpaced the department's capacity;

WHEREAS, the Probation Department is recommending a service expansion for the Adult Pretrial Services program in the form of additional staffing that will be funded by an allocation from the State for SB129 pretrial services and future years costs would be funded by the State's ongoing allocation for the Public Safety Realignment (AB109) program; and
