WHEREAS, Library specific classification/market increase recommendations, with the intent of updating classification specifications to current industry standards and increase the salaries consistent with the County Compensation Philosophy were approved by the Board on December 10, 2013 with an effective date of December 14, 2013;

WHEREAS, the market increase for the Library Page classification caused an unintended consequence by decreasing the salary below the amount contractually provided effective November 16, 2013;

WHEREAS, the Board seeks to adjust the Library Page classification consistent with the contractually provided amount effective November 16, 2013;

NOW, THEREFORE, effective December14, 2014 the Monterey County Board of Supervisors hereby resolved to approve the following:
