WHEREAS, Monterey County Human Resources Department (HRD) contracted the independent consulting firm of Koff and Associates to conduct a classification and compensation study of the Legal Secretary-Confidential and Senior Legal Secretary-Confidential classifications in the County Counsel's office; and

**WHEREAS**, the findings of the classification study determined that a new classification of Legal Secretary III be created; and

**WHEREAS**, it is recommended that the Legal Secretary-Confidential and Senior Legal Secretary Confidential positions be reallocated, and the incumbents be reclassified, to Legal Secretary III; and

**WHEREAS**, the findings of the compensation study determined that the salary of the Legal Secretary III be set at \$4286 - \$5854/monthly based on the labor market findings; and

**WHEREAS**, the actions require the Personnel Policies and Practices Resolution No. 98-394 Appendices A and B to be amended;

**NOW THEREFORE, BE IT RESOLVED THAT**, the Board of Supervisors in and for the County of Monterey as follows:
