Referral Title: Completion of the Monterey County Juvenile Hall		
Referral Purpose: For the Monterey County Probation Department and other county staff to pursue state grant funding to complete the unfinished phase of the new Juvenile Hall		
Brief Referral Description: The new Monterey County Juvenile Hall at 1420 Natividad Road in Salinas is near completion this year. However, a last phase of the project was not funded through descoping due to numerous construction problems and budget overruns. That phase would have included the construction of an additional housing wing, a dining facility, a commercial-grade kitchen and a laundry room. In FY 21/22, Senate Bill 823 changed state law to require local jurisdictions to house serious juvenile offenders that were previously housed in State institutions. These offenders must be housed in separate, more secure facilities, adding a significant financial burden to local jurisdictions.		
Since 2007, the Board of State and Community Correction (BHCC) has funded counties to improve existing juvenile detention facilities or build new ones through SB81 Local Youthful Offender Rehabilitative Facilities Construction lease revenue bonds, including \$35 million for this Juvenile Hall. This referral requests that staff and our grant consultant pursue any available state revenue to complete the unfinished portion of the Juvenile Hall.
