

**AMENDMENT 1
TO THE
SERVICES AGREEMENT
BETWEEN
NATIVIDAD MEDICAL CENTER
AND
THE REGENTS OF THE UNIVERSITY OF CALIFORNIA**

WHEREAS, the Regents of the University of California, a corporation described in California Constitution Art. IX, Sec. 9, on behalf of its UCSF School of Medicine, Department of Pediatrics (“UCSF”), and the County of Monterey (“County”) on behalf of Natividad Medical Center (“Hospital”) entered into a Professional Services and Medical Director Services Agreement (“Agreement”) with an effective date of July 1, 2021;

WHEREAS, UCSF and County wish to amend the pediatric hospitals clinical and medical director services (“Services”) UCSF provides to the Hospital;

WHEREAS, Natividad desires to continue to engage UCSF to provide Services under the Agreement;

WHEREAS, the UCSF desires to continue to provide Services under the Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained in this Agreement, the parties mutually agree to amend the Agreement as follows:

1. This Amendment 1 is effective as of January 1, 2022 (the “Effective Date”).
2. As of January 1, 2022, UCSF Physicians will no longer serve as Medical Director or provide Medical Director services under this Agreement.
3. Section 1.1(a), Medical Director Services, of the Agreement is deleted in its entirety.
4. Exhibit 1.1(a), Medical Director Services, of the Agreement is deleted in its entirety.
5. The following language replaces Section 1.1(b), Professional and Coverage Services of the Agreement:
 - (b) Professional and Coverage Services. UCSF shall provide Hospital professional services by its UCSF Physicians, who are board certified or eligible pediatricians to Hospital patients in need of pediatric hospitalist services while admitted as inpatients at Hospital (the "Professional Services") as identified in Exhibit 1.1(b) of this Agreement. UCSF Physicians shall provide on average three (3) to five (5) twenty-four (24) hour shifts per month with a total of no less than one thousand (1,000) hours per year, and not to exceed one thousand two hundred (1,200) hours per year (the “Minimum Coverage Services”).
6. Exhibit 4.1, Compensation, of the Agreement is deleted in its entirety and replaced with Exhibit 4.1 as attached to this Amendment 1 and incorporated in the Agreement by reference.

EXHIBIT 4.1

Compensation

1. Compensation.

For the period January 1, 2022 to June 30, 2022, Hospital shall pay UCSF the amount equal to \$14,963.16 per month (the "Base Compensation") for the Minimum Coverage Services rendered under this Agreement; provided, however, that UCSF is in compliance with the terms and conditions of this Agreement. In the event UCSF Physician provides less than Minimum Coverage Services set forth in Section 1.1, the Base Compensation shall be adjusted by \$152 for each hour below the Minimum Coverage Services.

If UCSF Physician is asked to provide more than the Minimum Coverage Services set forth in Section 1.1, Hospital shall pay \$173 per hour of Services rendered.

2. Timing. Hospital shall pay the Compensation due for Contracted Services performed by UCSF after UCSF's submission of the monthly invoice of preceding month's activity and time report in accordance with this Agreement; provided, however, that if UCSF does not submit an invoice and time sheet within sixty (60) days of the end of the month during which Contracted Services were performed, Hospital shall not be obligated to pay UCSF for Contracted Services performed during that month. The County of Monterey Standard Payment Terms for contracts/PSAs and paying invoices is "30 days after receipt of the certified invoice in the Auditor-Controller's Office."
