

**AMENDMENT NO. 7  
TO SERVICES AGREEMENT  
BETWEEN Prevent Life Safety Services Inc., AND  
NATIVIDAD MEDICAL CENTER  
FOR**

**Fire Protection, Fire Damper Inspection and Repair Services**

This Amendment No. 7 to the Services Agreement ("Agreement"), dated July 1, 2008, is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Prevent Life Safety Services Inc., (hereinafter "CONTRACTOR"), with respect to the following:

**RECITALS**

**WHEREAS**, the Agreement was executed for Fire Protection, Fire Damper Inspection and Repair Services with a one year term and a total Agreement amount not to exceed \$18,037; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on July 1, 2009 via Renewal Amendment No. 1 to extend the term for an additional one year period through June 30, 2010 and to add an additional \$18,000, thereby increasing the total agreement amount to \$36,037; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on July 1, 2010 via Amendment No. 2 to extend the term for an additional one year period through June 30, 2011 and to add an additional \$18,000, thereby increasing the total agreement amount to \$54,037; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on February 11, 2011 via Renewal and Amendment No. 3 to extend the term for an additional seventeen month period through June 30, 2012 and to add an additional \$15,000 thereby increasing the total agreement amount to \$69,037; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on July 1, 2012 via Amendment No. 4 to extend the term for an additional one year period through June 30, 2013 and to add an additional \$9,000 thereby increasing the total agreement amount to \$78,037; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on July 1, 2013 via Amendment No. 5 to extend the term for an additional one year period through June 30, 2014 with no increase and thereby maintain the total agreement amount to \$78,037; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on July 1, 2014 via Amendment No. 6 to extend the term for an additional one year period through June 30, 2015 and to add an additional \$21,963 thereby increasing the total agreement amount to \$100,000; and

**WHEREAS**, NMC and CONTRACTOR currently wish to amend the Agreement to allow for services to continue with an increase of \$2,333.39 for a total Agreement amount of \$102,333.39

**AGREEMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Renewal Amendment No 1, Amendment No. 2, Renewal and Amendment No. 3, Amendment No. 4, Amendment No. 5 and in Amendment No. 6 incorporated herein by this reference, except as specifically set forth below.

1. Section 1, "PAYMENTS BY NMC" shall be amended to the following; *"NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in EXHIBIT A plus Attachment A to Renewal Amendment No. 3 attached hereto this Amendment No. 7. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$102,333.39"*.
