Resolution honoring **Gill Campbell** as recipient of the Monterey Peninsula Chamber of Commerce 2013 Robert C. Littlefield Award for Lifetime Achievement

WHEREAS, the Monterey Peninsula Chamber of Commerce established the "Robert C. Littlefield Award for Lifetime Achievement" award in 1981, to honor the contributions of one of their outstanding volunteer members in remembrance of the late Robert C. Littlefield, a past President and long-time supporter responsible for reinvigorating the Chamber; and

WHEREAS, Gill Campbell is deemed to be a well-qualified recipient through meeting the criteria of the Robert C. Littlefield Award for Lifetime Achievement: being a member in good standing of the Monterey Peninsula Chamber of Commerce for many years, having exhibited significant support of the Monterey Peninsula Chamber of Commerce over several years, and having demonstrated leadership of the business community through Chamber volunteerism and participation; and

WHEREAS, Gill Campbell was born in Exeter, England and raised in the automobile industry, with the family business selling Morris Minors; her two older brothers raced alongside such greats as Colin Chapman and Stirling Moss; and

WHEREAS, Gill Campbell graduated in history and drama from Exeter University, St. Luke's College, and went on to become a teacher; and

WHEREAS, in 1975 Gill Campbell came to the Eugene, Oregon and began a career in event planning, coordinating a number of high profile events. In 1989, Portland's Global Events Group hired Gill which launched her career in motorsports; and

WHEREAS, Gill Campbell started Campbell Productions & PR LLC., an event, promotion and public relations firm. The company produced and promoted both motorsports and beer festivals, including the Portland Historic Races, The American La Mans Series and the Oregon Brewers Festival in addition to working with the Monterey Historic Automobile Races and the NASCAR Craftsman Truck Series; and

WHEREAS, in 2002 Gill Campbell became the CEO/General Manager of the Sports Car Racing Association of the Monterey Peninsula (SCRAMP) located at Mazda Raceway Laguna Seca, a world renowned facility that hosts five major motorsports events, including the Ferrari Challenge, the eni FIM Superbike World Championship, the Rolex Monterey Motorsports Reunion Races, the Tudor United SportsCar Championship and the Porsche Rennsport Reunion; and

WHEREAS, Gill Campbell's many contributions include; Board of Directors for the Monterey Convention and Visitors Bureau; President of the Road Racing Industry Council Board; Steering Committee for the LeMay-America's Car Museum and Rabobank Regional Presidents' Advisory Council; and

WHEREAS, Gill Campbell was nominated in 2007 as a Woman of Distinction by the San Jose Business Journal, she was named "Promoter of the Year" in 2008 by the American Le Mans Series, and received the Economic Vitality Award from the combined Monterey area Chambers of Commerce in 2012.

NOW, THEREFORE, BE IT RESOLVED, that the Monterey County Board of Supervisors, on behalf of the County and all citizens thereof, congratulates Gill Campbell as she receives the Monterey Peninsula Chamber of Commerce's 2013 Robert C.
