AMENDMENT NO. 1
UTILITY AGREEMENT NO. 3820.02
 BETWEEN COUNTY OF MONTEREY AND
 CALIFORNIA AMERICAN WAER COMPANY

THIS AMENDMENT NO. 1 to the Utility Agreement No. 3820.02 between the County of Monterey, a political subdivision of the State of California hereinafter, "County and California American Water Company, hereinafter called "Cal-Am", a California corporation which was executed by the County on March 27, 2012. Cal-Am owns and maintains water distribution facilities within the County.

WHEREAS, the County and Cal-Am wish to amend the Agreement to allow the reimbursement of cost associated with the installation of Force Balanced Flex-tend Flexible Expansion joints, two new gate valves, and other ancillary piping components to improve the function of the pipeline.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Amend the first paragraph of Section IV, "PAYMENT FOR WORK", to read as follows:

Cal-Am shall pay the cost to relocate its facilities located within the project limits. The initial project cost estimate, based on the contract bid items, was \$155,100 and consisted of the following bid items:

Item No. 23 - Relocate Water Utility Lines	\$105,000
Item No. 24 - Relocate Water Meter	26,600
Item No. 25 - Adjust Water Meter	6,000
Item No. 26 - Relocate Water Valve	17,500

Cal-Am also provided the County a 10% contingency of said work, for a total of \$170,610. During the course of construction Cal-Am has requested that extra work be done by the contractor, via contract change order, in the amount of \$44,439.92. Cal- Am agrees to reimburse the County the outstanding amount of \$28,929.92 plus an additional

5% overall contingency for a total of \$39,337. Cal-Am shall pay this amount within 90 days upon receipt of County's invoice, signed by a representative of County's organization and prepared on County's letterhead.

2. All other terms and conditions of the Agreement remain unchanged and in full force.
3. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
