WHEREAS, Article 5 (commencing with Section 21150) of Division 5 of Title 2 of the California Government Code establishes the circumstances under which an employee who is a member of the California Public Employees' Retirement System (CalPERS) may be granted a disability retirement; and

WHEREAS, the County of Monterey is a contracting agency of CalPERS; and

WHEREAS, pursuant to Government Code subsections 21152(c-d), application to CalPERS for disability retirement may be initiated by the governing body, or by an official designated by the governing body of the contracting agency, or the CalPERS member or any person on his/her behalf; and

WHEREAS, the Board of Supervisors has previously delegated to the County Administrative Officer the authority to make disability retirement applications to CalPERS by form of letter dated March 8, 1982, and although such authority continues until the present day, CalPERS has requested a Board of Supervisors resolution delegating the Board's authority be submitted to CalPERS.

WHEREAS, following an application to CalPERS for disability retirement, pursuant to Government Code sections 21156(a)(1) and 21159, the Public Employees' Retirement Law requires a contracting agency determine whether an employee of such agency in employment in which he/she is certified as a local safety member is disabled for purpose of the Public Employees' Retirement Law and whether such disability is "industrial" within the meaning of such Law; and

WHEREAS, pursuant to Government Code section 21173, the County may delegate authority to make such industrial disability determination to the County Administrative Officer.

NOW, THEREFORE, THE COUNTY OF MONTEREY DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1: The Board of Supervisors hereby affirms it has delegated to the County Administrative Officer authority to make applications on behalf of the County pursuant to Government Code subsection 21152(c) for disability retirement of all employees and to initiate requests for reinstatement of such employees who are retired for disability; and

SECTION 2: The Board of Supervisors delegates to the County Administrative Officer authority to make determinations of disability on behalf of the County under Government Code section 21156 and whether such disability is industrial and to certify such determination and all other necessary information to CalPERS.

SECTION 3: Effective Date. This Resolution is effective on the day of its adoption.


