AMENDMENT NO. 7 TO PARAMEDIC SERVICE PROVIDER AGREEMENT BETWEEN COUNTY OF MONTEREY AND MONTEREY COUNTY REGIONAL FIRE DISTRICT

THIS AMENDMENT No. 7 is made to the Paramedic Service Provider Agreement ("AGREEMENT") by and between the Monterey County Regional Fire District, hereinafter referred to as "PROVIDER," and the County of Monterey, a political subdivision of the State of California, acting through its Emergency Medical Services Agency (EMSA), hereinafter referred to as "COUNTY."

WHEREAS, on or about March 28, 2012, COUNTY and PROVIDER entered into an AGREEMENT for the provision of paramedic services in the County of Monterey for a period of four (4) years effective March 28, 2012; and

WHEREAS, on or about March 16, 2017, COUNTY and PROVIDER entered into an AGREEMENT TO RETROACTIVELY RENEW AGREEMENT, retroactive to March 28, 2016 for the provision of paramedic services in the County of Monterey; and amending the agreement to extend to June 30, 2017; and

WHEREAS, on or about July 24, 2017, COUNTY and PROVIDER entered into and executed Amendment No. 2 to extend the AGREEMENT on the same terms and conditions to June 30, 2018; and

WHEREAS, on or about July 12, 2018, COUNTY and PROVIDER entered into and executed Amendment No. 3 to extend the AGREEMENT on the same terms and conditions to January 31, 2020; and

WHEREAS, on or about February 13, 2020, COUNTY and PROVIDER entered into and executed Amendment No. 4 to extend the AGREEMENT on the same terms and conditions to January 31, 2022; and

WHEREAS, on or about March 10, 2022, COUNTY and PROVIDER entered into and executed Amendment No. 5 to extend the AGREEMENT on the same terms and conditions to July 31, 2022; and

WHEREAS, on or about July 27, 2022, COUNTY and PROVIDER entered into and executed Amendment No. 6 to extend the AGREEMENT on the same terms and conditions to January 31, 2025; and

WHEREAS, COUNTY and PROVIDER wish to amend the AGREEMENT to extend the AGREEMENT for a period of three (3) months to June 30, 2025; and

NOW THEREFORE, COUNTY and PROVIDER hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 1 of AGREEMENT shall be amended by removing "Once signed by the authorized representatives for all parties, this agreement becomes effective at 8:00 a.m. on 3-28-2012 and shall continue through January 31, 2025" and replacing it with "Once signed by the authorized representatives for all parties, this agreement becomes effective at 8:00 a.m. on March 28, 2012 and shall continue through June 30, 2025."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT, AGREEMENT TO RETROACTIVELY RENEW AGREEMENT, AMENDMENT No. 2, AMENDMENT No. 3, AMENDMENT No 4, Amendment No. 5, and AMENDMENT No. 6 shall continue in full force and effect.
- 3. A copy of AMENDMENT No. 7 shall be attached to the original AGREEMENT dated March 28, 2012 and shall be incorporated therein as if fully set forth in the AGREEMENT.
