RESOLUTION AND ORDER OF APPOINTMENT

This Resolution and Order of appointment is made with reference to the following facts and circumstances:

WHEREAS, Mary Zeeb is the duly elected Treasurer-Tax Collector of the County of Monterey, whose term of office ends at 11:59 am on Monday, January 4, 2027; and,

WHEREAS, the Board of Supervisors is informed that Mary Zeeb intends to retire, pursuant to Government Code Section 1750, as Treasurer-Tax Collector effective December 30, 2025, leaving one year remaining in her four-year term; and,

WHEREAS, the Board is asked to consider the appointment of Jake Stroud as Treasurer-Tax Collector with a term commencing at 5:01 pm on December 30, 2025; and,

WHEREAS, the appointment of Jake Stroud as Treasurer-Tax Collector will ensure the continuity of operational services and departmental leadership through the remainder of the unexpired term ending on January 4, 2027, at 11:59 am.

NOW, THEREFORE, BE IT RESOLVED, the County of Monterey Board of Supervisors ACKNOWLEDGES the retirement of Mary Zeeb as the Treasurer-Tax Collector of the County of Monterey effective December 30, 2025, and her contributions to the County of Monterey and its residents during her tenure as Treasurer-Tax Collector; and,

FURTHERMORE, the County of Monterey Board of Supervisors hereby APPOINTS Jake Stroud as the County's Treasurer-Tax Collector for the period of December 30, 2025, at 5:01 pm, through the remainder of the unexpired term ending on January 4, 2027 at 11:59 am. During the term of his appointment, Jake Stroud shall have all powers, and shall promptly and faithfully discharge all duties and responsibilities, of the Office of the Treasurer-Tax Collector. The appointment shall become effective on or after December 30, 2025, at 5:01 pm.


