**WHEREAS**, **Tiffanie Newcomer**, during her time off, volunteered to drive homeless veterans to job interviews, helped move furniture into their “new” homes and helped active duty airmen who are away from home for the first time by baking and delivering over sixteen hundred cupcakes and cookies over three different holidays; and

**WHEREAS**, **Tiffanie Newcomer** has significantly improved the lives of veterans and active duty members all over Monterey County and her efforts epitomize the spirit of community service.
