GREENWAY, P.E., ACTING DIRECTOR OF PUBLIC WORKS of Monterey County, California, do hereby certify that a contract between the COUNTY OF MONTEREY and GRANITEROCK CONSTRUCTION DBA PAVEX CONSTRUCTION DIVISION, 411 Walker Street, Watsonville, California 95076, was entered into on July 12, 2005, for the SAN MIGUEL CANYON ROAD/HALL ROAD INTERSECTION IMPROVEMENTS, PROJECT NO. 05-152065. The construction work was inspected on May 15, 2007, and was determined to have been satisfactorily performed in accordance with the Plans and Special Provisions. Also a five-year Plant Establishment commenced on November 21, 2006 and was inspected on April 17, 2012. The five-year Plant Establishment was determined to be satisfactory since the re-vegetation achieved the target survival rate of 80%. The Board of Supervisors accepted this work on July 10, 2012, and thus deemed complete in accordance with the Plans and Special Provisions.

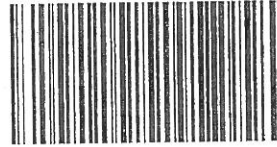
