

#### Location

• Approximately 344 acres, North of Harper Canyon Road and San Benancio Road, East of Highway 68, West and Southwest of Toro Regional Park

#### Project

• 17 lot residential subdivision on approximately 164 acres with a 180 acre remainder lot to be dedicated as open space

#### Backgroun d

- Applied December 2000
- Initial Study prepared 2003
- Directed to prepare an EIR by Planning Commission in 2005
- Draft EIR prepared 2008
- Final EIR prepared 2010
- Planning Commission 2010 continued due to complaint with CPUC over the Ambler Park water system
- 2014 PC denies application (appealed to Board)
- May 2014 Board adopts motion of intent to deny the project
- New water testing information presented 2014
- March 2015 Board considers new water testing information and adopts a motion of intent to approve
- April 2015 Board denies appeal and approves the project
- CEQA Lawsuit filed
- 2018 Superior Court rules in favor of petitioners on water and wildlife corridor issues
- Appeals and cross appeals filed on ruling
- 2021 Court of Appeal overturns Superior Court ruling on water but agrees on wildlife corridor.
- 2021 County rescinds 2015 approval with respect to wildlife corridor issues (following Court of Appeal orders)



- Wildlife corridor between Fort Ord National Monument, Toro Park, and Santa Lucias




