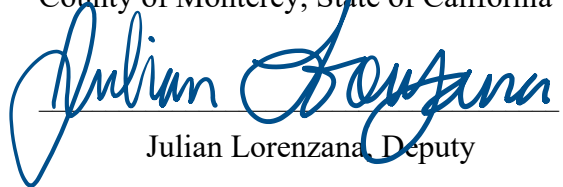

**RENEWAL AND AMENDMENT NO. 3
TO THE RAL SOFTWARE SYSTEM LICENSE AND SUPPORT MASTER AGREEMENT
BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND
ABBOTT RAPID DIAGNOSTICS INFORMATICS, INC. (FORMERLY ALERE INFORMATICS, INC.)
FOR
RALS SOFTWARE SYSTEM AND ASSOCIATED COMPONENTS AND AL DEVICE MODULE
SOFTWARE**

This Renewal and Amendment No. 3 to the RAL Software System License and Support Master Agreement ("Master Agreement") is made and entered into, by and between the County of Monterey (hereinafter "County"), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "Customer"), and Abbott Rapid Diagnostics Informatics, Inc. (hereinafter, "ARDx Informatics" and "Abbott Rapid Diagnostics Informatics, Inc."); (collectively, **Customer, ARDx Informatics and Abbott Rapid Diagnostics Informatics, Inc.**) are referred to as the "**Parties**" to this Agreement, with respect to the following:

RECITALS

WHEREAS, the County of Monterey on behalf of Natividad Medical Center and Alere Informatics, Inc. had previously entered into the RAL Software System License and Support Master Agreement (hereinafter "Master Agreement") on May 15, 2016 to provide access to the RALS software system, a Roche Glucose module, with a one-year term (May 15, 2016 through May 14, 2017) and a total Agreement amount not to exceed \$12,025; and

WHEREAS, the Parties amended the Agreement via Amendment No. 1 to add a Nova Statstrip module (Exhibit A-2) with a term of May 14, 2017 through May 13, 2022, for an increase of \$61,204.50, thereby increasing the total Agreement amount to \$73,229.50, while allowing the Roche Glucose module to expire; and

WHEREAS, Alere Informatics, Inc. had a legal name change on October 1, 2019 to Abbott Rapid Diagnostics Informatics, Inc.; and

WHEREAS, the Parties amended the Agreement via Amendment No. 2 on April 23, 2019 to add a HemoCue DM HB module (Exhibit A-3), an i-STAT module (Exhibit A-4), a Siemens Healthineers Clinitek Status Connect module (Exhibit A-5), and a Nova StatSensor CREAT module (Exhibit A-6), for a total additional cost of \$191,472.50, thereby increasing the total Agreement amount to \$264,702, and each software module added via amendment No. 2 had term of use valid from April 23, 2019 through April 24, 2024, but the Agreement term was not extended past May 13, 2022 in error; and

WHEREAS, the Agreement term expired on May 13, 2022; and

WHEREAS, the Parties wish to renew the agreement retroactively to May 14, 2022 and amend on the same terms to extend the Agreement term through April 24, 2024, and to add a new Nova StatStrip GLU (Glucose) module (Exhibit A-7 attached hereto this Renewal and Amendment No. 3) with a term of use valid May 14, 2022 through April 24, 2024, for a total added cost of \$35,514, thereby increasing the total Agreement amount to \$300,216.

AGREEMENT

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement and in Amendment No. 1 and Amendment No. 2 incorporated herein by this reference, except as specifically set forth below.

1. Paragraph 4, "TERM", shall be amended to the following:
"The term of this Agreement is from May 15, 2016 through April 24, 2024 unless sooner terminated pursuant to the terms of this Agreement. The Agreement term may be extended by both parties via an amendment to this Agreement signed by both parties."
2. Paragraph 5 of the Agreement, "Payments", shall be amended to the following:
"In consideration for the licenses granted hereunder, Customer shall pay Abbott Rapid Diagnostics Informatics, Inc. the fees set forth in Exhibits A-3, A-4, A-5 and A-6 attached to Amendment No. 2, and also in Exhibit A-7 attached hereto this Renewal and Amendment No. 3. The total amount of the Agreement shall not exceed \$300,216."
3. If there is any conflict or inconsistency between the provisions of Agreement, or this Renewal and Amendment No. 3, the provisions of this Renewal and Amendment No. 3 shall govern.
4. This Renewal and Amendment is effective retroactively on **May 14, 2022**.

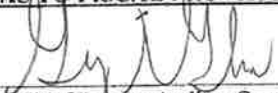

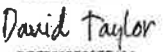

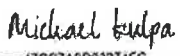
