## AMENDMENT NO. 1 TO SOFTWARE LICENSE AGREEMENT BETWEEN ARXIUM, INC. AND NATIVIDAD MEDICAL CENTER FOR

## PHARMACY PURCHASING AND INVENTORY MANAGEMENT SOFTWARE

This Amendment No. 1 to the Software License Agreement ("Agreement") which was effective on April 19, 2017 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "LICENSEE"), and ARXIUM, Inc. (hereinafter "LICENSOR"); (collectively, the County, LICENSEE and LICENSOR are referred to as the "Parties"), with respect to the following:

## RECITALS

**WHEREAS**, the Agreement was effective August 1, 2016 through January 31, 2018 for Pharmacy Purchasing and Inventory Management Software for a total Agreement amount of \$55,000; and

WHEREAS, LICENSEE and LICENSOR agree that the total agreement amount of \$55,000 was only enough to cover the first year's costs and the parties now wish to amend the Agreement to increase the total amount by an additional \$55,000 so as to cover costs for the second year of the agreement, for a revised total agreement amount of \$110,000 with no change to the Agreement scope or term.

## **AGREEMENT**

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

- 1. The following sentence shall be added to the end of <u>Section 4.3</u> as follows: "The total amount payable by LICENSEE to LICENSOR under this Agreement shall not exceed the sum of \$110,000."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Original Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 3. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
- 4. This Amendment No. 1 shall be effective when signed by both parties.
