WHEREAS, Jan Zeigler, is a past secretary, treasurer, and chair of the Monterey County Chapter of the American Civil Liberties Union; and

WHEREAS, Jan Zeigler, is also a past board member of the Monterey Chapter of the League of United Latin American Citizens and has served on the Mental Health and Police Practices Task Force; and

WHEREAS, Jan Zeigler and William Zeigler, helped to organize numerous fundraising activities for the old Monterey and Salinas NAACP Branches and were both instrumental in their merger into the united Monterey County Branch in 2006; and

WHEREAS, Jan Zeigler, served on the first Executive Committee of the new Monterey County Branch NAACP and sewed the banner still used by the Branch to this day; and

WHEREAS, Jan Zeigler, tremendously contributed to the NAACP by recruiting Mr. William Zeigler; and

WHEREAS, William Zeigler, joined the United State Army on July 25, 1977 where he served ten years with two overseas tours in Germany, the first in Frankfurt and the second in Bamberg; and

WHEREAS, William Zeigler is one of the Senior Military & Veterans Affairs Services Representatives of Monterey County, where, in May 2016, he will have served ten years; and

**WHEREAS**, **William Zeigler** was the Chair of the Monterey County Chapter of the American Civil Liberty Union from February 1997 to February 1999, and remains a Board member of the Monterey County Chapter; and

WHEREAS, William Zeigler was a part-time faculty member at the Monterey Peninsula College from Fall term of 1997 to the Summer term 2000, where her taught two courses, which were "Inter-Cultural Relations in America Society", and "African Americans in American Government"; and

WHEREAS, William Zeigler has a master's in Public Administration from Golden Gate University, a Bachelor of Art in Social Science from San Jose State University, and an Associate's degree from Monterey Peninsula College; and

WHEREAS, from January 6, 2007 to January 2009, William Zeigler was the President of the newly inaugurated Monterey County Branch of the National Advancement of Colored People (the Seaside Branch, and the Salinas Branch were emerged); and
