Adopt Resolution Recognizing **Carl G. Sedoryk** For His Exemplary Twenty-Five Year Anniversary with Monterey- Salinas Transit.

WHEREAS, Carl G. Sedoryk began his career with Monterey-Salinas Transit in June 2000, as the Assistant General Manager and transitioned into the role of General Manager/CEO in September 2005; and

WHEREAS, Carl G. Sedoryk oversaw many successful MST infrastructure and technology initiatives to better serve passengers and the community including construction of the Marina Transit Exchange, JAZZ bus rapid transit (BRT), RealTime bus arrival system, Mobility Services Center, contactless fare payments, and the future SURF! Busway and BRT; and

WHEREAS, Carl G. Sedoryk implemented new transit services for the popular visitor-serving Monterey Trolley, service to south county cities on line 23 Salinas-King City, the Grapevine Express (line 24 Monterey-Carmel Valley), line 55 Monterey-San Jose Express, military serving lines, line 84 King City-Paso Robles, line 59 Salinas-Gilroy, and a major overhaul of the entire transit system with the Better Bus Network; and

WHEREAS, During Carl G. Sedoryk's 25 years, MST has been called up to respond to several emergency events and coordinate with the Monterey County Department of Emergency Management including the COVID-19 pandemic and emergency evacuations from fires and floods; and

WHEREAS, During Carl G. Sedoryk tenure as the General Manager/CEO, MST has received numerous awards for transportation excellence from the American Public Transportation Association, the California Transit Association, and the Transportation Agency for Monterey County; and

WHEREAS, During his 25 distinguished years at MST, **Carl G. Sedoryk** has secured over \$200M in federal, state, and local grant funding for infrastructure, technology, and service initiatives, managed a budget that contributed \$1.5B to the local economy through direct and induced spending, and served more than 100 million passengers; and

WHEREAS, Carl G. Sedoryk is widely respected as a passionate advocate for public transportation serving our communities and nationally, as a spirited and principled leader, consistently demonstrating a sense of responsibility for the well-being of MST employees and passengers, while championing safety and fairness as core values.

NOW, THEREFORE BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby recognizes and congratulates **Carl G. Sedoryk** on his Twenty-Five Year Anniversary with Monterey-Salinas Transit.
