WHEREAS, for more than nineteen years, **Gerardo Magaña** has organized and personally contributed to the Annual Christmas Toy Drive in East Salinas, providing holiday cheer to hundreds of children and families while strengthening community trust in law enforcement; and

WHEREAS, **Gerardo Magaña’s** service extends beyond policing through his participation in the Cops Care Cancer Foundation Fantasy Flight, the Salinas Valley Chamber of Commerce Foundation’s Children’s Shopping Tour, and other charitable community events that uplift youth and families; and

WHEREAS, year-round, **Gerardo Magaña** remains a visible and approachable presence in the community, offering public talks, providing crime updates on Spanish-language radio, and returning to his alma mater, Los Padres Elementary, to inspire students and support families.
