A motion was made by Supervisor Luis A. Alejo, seconded by Supervisor John M. Phillips to:

**Agreement No.: A-14492, Amendment No. 2**

- a. Authorize the Chief Executive Office for Natividad or his designee to execute the Second Amendment to the Professional Services Agreement (A-14492) with The Regents of the University of California, a public corporation, on behalf of the University of California, San Francisco, School of Medicine, Department of Pediatrics (UCSF) to provide pediatric cardiology services extending the term by twelve months (January 1, 2021 to December 31, 2021) for a revised full agreement term of January 1, 2018 to December 31, 2021, and adding \$200,000 for a revised total not to exceed amount of \$500,000 in the aggregate; and
- b. Authorize the Chief Executive Office for Natividad to sign up to three (3) future amendments to this agreement where the total amendments do not significantly change the scope of work and do not cause an increase of more than ten percent 10% (\$10,000) of the original contract amount per each amendment.



**Second Amendment  
To  
Professional Services Agreement  
(Pediatric Services)**

This Second Amendment to Professional Services Agreement – Pediatric Services (“Second Amendment”) is made and entered into by and between The Regents of the University of California, a public corporation, on behalf of the University of California, San Francisco, School of Medicine, Department of Pediatrics (hereinafter referred to as "UCSF"), and the County of Monterey (“County”), on behalf of Natividad Medical Center (hereinafter referred to as “Hospital”).

**RECITALS:**

**WHEREAS**, UCSF and Hospital have heretofore entered into that certain Professional Services Agreement – Pediatric Services (“PSA”) for UCSF to provide pediatric cardiology services on behalf of Hospital for the period beginning January 1, 2018 and amended September 1, 2019 (collectively, “the Agreement”); and

**WHEREAS**, Section 15.5 of the Agreement, Amendments, permits the parties to amend the Agreement by mutual written consent of duly authorized representatives of the parties;

**NOW THEREFORE**, UCSF and Hospital hereby agree to amend the Agreement, as follows:

1. Section 3.1 t to the Agreement is hereby deleted in its entirety and replaced with the following:  
“3.1 Compensation to UCSF for Contract Services. HOSPITAL shall pay to UCSF the amount determined in accordance with Exhibit 3 (the “Compensation”), upon the terms and conditions set forth therein. The total amount payable by Hospital to UCSF under this Agreement shall not exceed the sum of Five Hundred Thousand Dollars (\$500,000).”
2. Section 4.1 t to the Agreement is hereby deleted in its entirety and replaced with the following:  
“4.1 Term. This Agreement shall become effective on January 1, 2018 (the “**Effective Date**”), and shall continue until December 31, 2021 (the “**Expiration Date**”), subject to the termination provisions of this Agreement.”
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Second Amendment and shall continue in full force and effect.
4. The effective date of this Second Amendment is January 1, 2021.


