- a. Approve and authorize the Contracts/Purchasing Officer or their designee to execute Renewal and Retroactive Amendment No. 3 to Agreement No. A-16556 with SCRAM of California, Inc. to provide electronic monitoring products and services for Probation clients, to renew and extend the expiration date of June 30, 2024 for one (1) additional year, for a revised term of June 1, 2023 through June 30, 2025, and to increase the Agreement's amount by \$200,500 for a revised total Agreement amount not to exceed \$500,721; and
- b. Authorize the Contracts/Purchasing Officer or their designee to execute future amendments to the Agreement where the total amendments do not exceed 15% (\$75,108) of the Agreement amount and do not significantly change the scope of services, for a not to exceed maximum amount of \$575,829.

**RENEWAL AND AMENDMENT NO. 3
TO STANDARD AGREEMENT
BETWEEN COUNTY OF MONTEREY AND
SCRAM OF CALIFORNIA, INC.**

THIS RENEWAL AND AMENDMENT NO. 3 to Standard Agreement A-16556 between the County of Monterey, a political subdivision of the State of California (hereinafter, “County”) and **SCRAM of California, Inc.** (hereinafter, “CONTRACTOR”) is hereby entered into between the County and CONTRACTOR (collectively, “the Parties”) and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Standard Agreement A-16556 with the County on September 1, 2023 with a retroactive start date of June 1, 2023, (hereinafter, “Agreement”) to provide an electronic monitoring program for Probation clients (hereinafter, “services”) through December 31, 2023, for an amount not to exceed \$145,655; and

WHEREAS, the Agreement was amended by the Parties on January 5, 2024 (hereinafter, “Amendment No. 1”) to extend the term for six (6) additional months through June 30, 2024 and to increase the Agreement’s amount by \$14,566 for a total not to exceed amount of \$160,221; and

WHEREAS, the Agreement was amended by the Parties on March 19, 2024 (hereinafter, “Amendment No. 2”) to update the Contractor’s Fee Schedule and to increase the Agreement’s amount by \$140,000 for a total not to exceed amount of \$300,221 with no change to the existing term date ending June 30, 2024; and

WHEREAS, the Parties have negotiated a revised tiered rate for the SCRAM Continuous Alcohol Monitoring + ETHERNET device and the Parties wish to update this rate effective July 1, 2024; and

WHEREAS, the Agreement expired on June 30, 2024 and the County has a continued need for services; and

WHEREAS, the Parties wish to renew the Agreement on similar terms retroactive to July 1, 2024 and increase funding to allow CONTRACTOR to continue to provide the services required by the County; and

WHEREAS, the Parties wish to further amend the Agreement to update the rate schedule, extend the term of the Agreement for one (1) additional year through June 30, 2025, and to increase the Agreement’s amount by \$200,500 for a total not to exceed amount of \$500,721 to allow CONTRACTOR to continue to provide the services identified in the Agreement and as amended by this Amendment No. 3.

NOW THEREFORE, the Parties agree to retroactively amend the Agreement as follows:

1. Amend the second sentence under Section 2.0, "Payment Provisions", to read as follows:

The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$500,721.

2. Amend the first sentence of Paragraph 3.01 of Section 3.0, "Term of Agreement", to read as follows:

The term of this Agreement is from June 1, 2023 to June 30, 2025, unless sooner terminated pursuant to the terms of this Agreement.

3. Amend the first sentence of Sub-Section B.1 "Compensation/Payment" of "Exhibit A – Scope of Services/Payment Provisions" to read as follows:

County shall pay an amount not to exceed \$500,721 for the performance of all things necessary for or incidental to the performance of work as set forth in the Scope of Services.

4. Replace "Attachment A – Fee Schedule, Effective March 1, 2024" with the revised fee schedule attached hereto as "Attachment A-1 – 1 Fee Schedule, Effective July 1, 2024."

5. Except as amended herein, all other terms and conditions of the Agreement, including all Exhibits thereto, remain in full force and effect as set forth in the Agreement.

6. This Amendment No. 3 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

IN WITNESS WHEREOF, the Parties hereto have executed this Amendment No. 3 to the Agreement which shall be effective as of the last date opposite the respective signatures below.
